The U.S. Nuclear Regulatory Commission (NRC) staff received and docketed your letter dated November 28, 2016, revising the site emergency plan. Your letter stated that the revisions do not decrease the effectiveness of the plan.

We have completed an acceptance review and identified no major deficiencies. In accordance with the Staff Requirements Memorandum for SECY-16-0009, "Recommendations Resulting from the Integrated Prioritization and Re-Baselining of Agency Activities" (Agencywide Documents Access and Management System [ADAMS] Accession Number ML16104A158), licensing staff will no longer perform a detailed review of such documents. Therefore, no cost activity code has been assigned to this action. A detailed review may be performed by inspection staff during a future inspection.
