On March 2, 2017, the staff from the U.S. Nuclear Regulatory Commission (NRC) and representatives from NuScale Power, LLC (NuScale) held an opened meeting via teleconference.

The NRC staff has been conducting an acceptance review on the NuScale Design Certification Application (DCA) since January 17, 2017. The purpose of the acceptance review is to determine if the NuScale DCA is complete and technically sufficient for the NRC staff to conduct the full DCA review on a predictable schedule.

During the course of the acceptance review it was determined that additional supporting information was needed. The areas identified to NuScale were: design basis seismic demand and combined static and seismic demands at representative locations of the seismic Category I structures (i.e., critical sections) and data supporting reactor systems related topical reports. The NRC requested that NuScale provide the requested information by March 10, 2016.
