Discussion:

Mr. Garcia provided the model and manufacturer of the device containing the Cd-109 sealed source. The device is a custom made source holder for use in research.

Mr. Garcia provided the sealed source model number and manufacturer for the Cd-109 sealed source. The manufacturer is currently Eckert and Zeigler Isotope Products and the model is XFB Series. The SSD for this source series has not been updated and still reads Isotope Products Laboratories.

The XFB Series source SSD was verified with the manufacturer. The SSD is CA0406S112S.

Mr. Garcia was informed that the license would be reformatted in accordance with current NRC policy, and that the XFB Series source would reflect the manufacturer on the SSD, Isotope Products Laboratories.
