Dear Mr. Sorrells:

Enclosed is Amendment No. 62 to your NRC Material License No. 13-00155-12 in accordance with your request. Please note that your license format was changed based on our new licensing process. In addition, we updated Items 6, 7, 8, and 9 based on your provided information and also updated the following License Conditions in accordance with our licensing policy: Condition 11 regarding the training requirement for users, Condition 13 regarding the sealed source leak test requirement, and Condition 15 regarding the biannual inventory requirement.

In the letter dated March 18, 2015, you provided that the licensee possessed an Ohmart Corporation Model SR-1 fixed gauge. In the letter dated February 17, 2017, you provided a copy of your licensed material inventory. However, we could not locate this model in your inventory. In addition, we have not received a request to remove this model from your license. Therefore, we listed it on this license amendment.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
