Dear Mr. Kautsky:

I am writing in response to the U.S. Department of Energy (DOE) position paper entitled "Origin of Contamination in Many Devils Wash, Shiprock, New Mexico" dated January 2017 (Agencywide Documents Access and Management System [ADAMS] Accession No. ML17034A048). The U.S. Nuclear Regulatory Commission (NRC) staff have reviewed the position paper, and the references cited in the position paper supporting the DOE position that the contamination in Many Devils Wash is not from mill related activities, and do not have any questions at this time.

Based on the NRC staff's review of the position paper, and the references cited therein, it appears that the upper part of Many Devils Wash was not affected by mill related activities. However, it would be helpful if the DOE outlined what area at the Shiprock site is affected by the conclusions of the position paper and where the DOE considers the boundary of Many Devils Wash to be. This is especially true for the lower portion of Many Devils Wash, downgradient of the buried escarpment, which appears to be hydraulically connected to the eastern terrace.

We understand that, in the future, the DOE may use the position paper, and the references in the paper, to inform a potential revision to the Groundwater Corrective Action Plan (GCAP) for the Shiprock site. NRC staff will review any proposed revisions to the GCAP when they are submitted by the DOE.
