Thank you for your time and hospitality on March 13th during the unannounced inspection of Beebe Medical Center. Ms. Gaskins and I need the additional two items to complete are inspection.

- 1) Can you please provide us with the number of sources, activity per source, and total activity of the Ge-68 sources in the box that was discovered in Mr. Mapes office?
- 2) Your Radioactive Waste Disposal Procedure states the following on page 2: "When a container is full, seal it with a string or tape and attach an identification tag that includes the date sealed, the longest-lived radioisotope in the container, the date when the half-lives of the longest lived radioisotope will be reached, the type of material (e.g. paraphernalia, unused doses, etc.) and the initials of the person sealing the container. Record all information that is required on the identification tag and the I.D. number of the container into which it is deposited in the Waste Disposal Record Log maintained. Decay radioactive Material for at least ten half lives." Please submit a letter signed by Mr. Mapes making a commitment to follow the radioactive waste disposal procedure for all items held for decay in storage in the hot lab(s) and in the Nuclear Medicine Decay Room – Basement.
