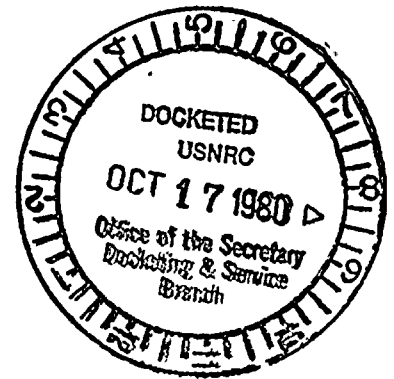

FOR CLARIFICATION OF BOARD ORDER OF OCTOBER 6, 1980

In its October 10, 1980 Request for Clarification, Pacific Gas and Electric Company ("PG&E") suggests that only it should have the opportunity to present rebuttal testimony. In the event this Board decides that rebuttal testimony will be permitted, Governor Brown requests that all participants be given the same opportunity to submit such testimony. In view of the simultaneous filing of direct testimony, there would be no basis for according only PG&E the opportunity to submit rebuttal testimony.

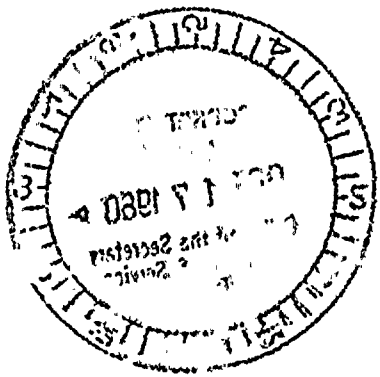

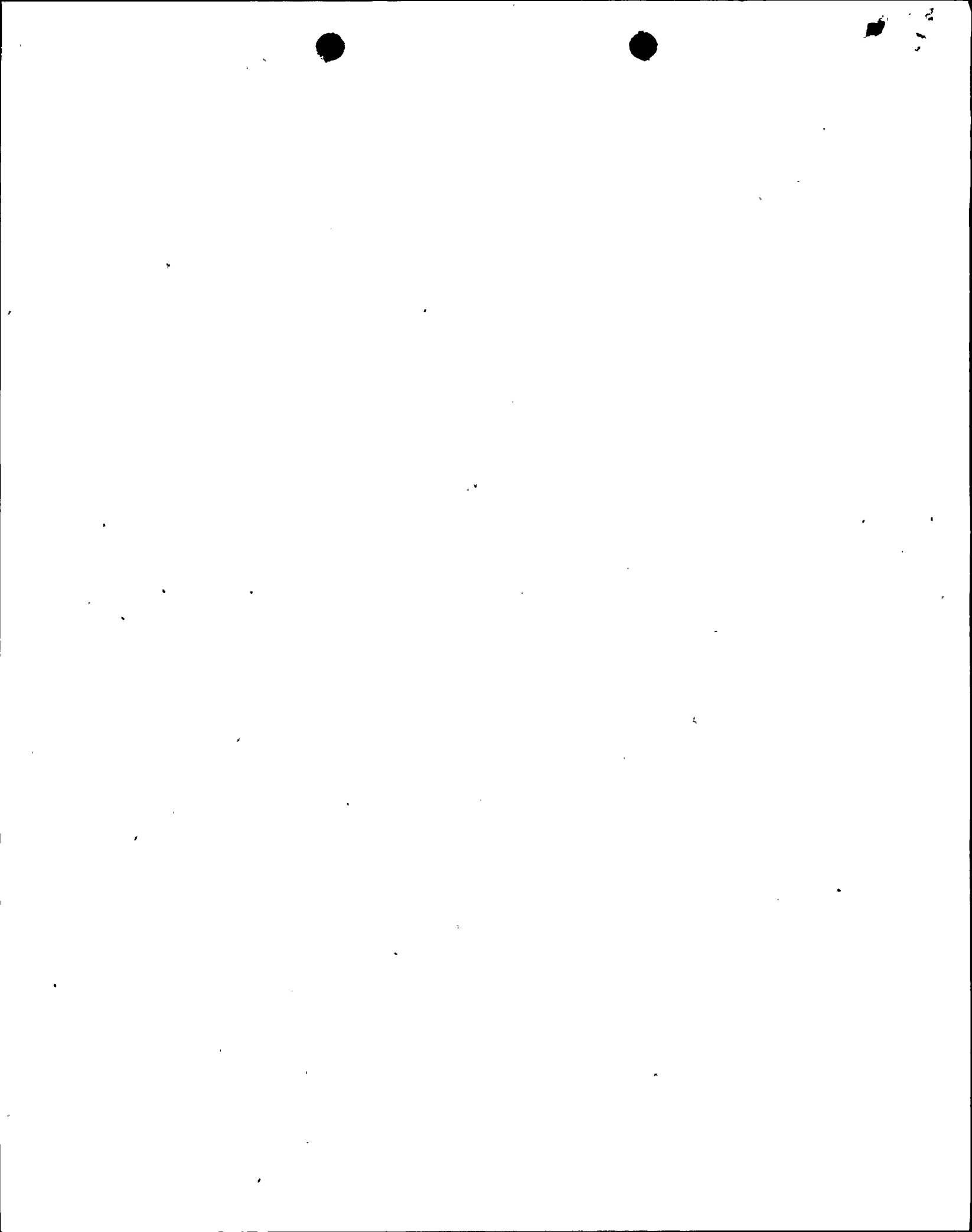
