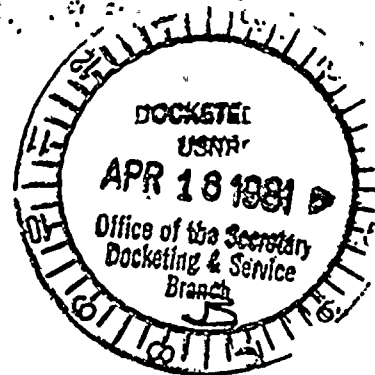

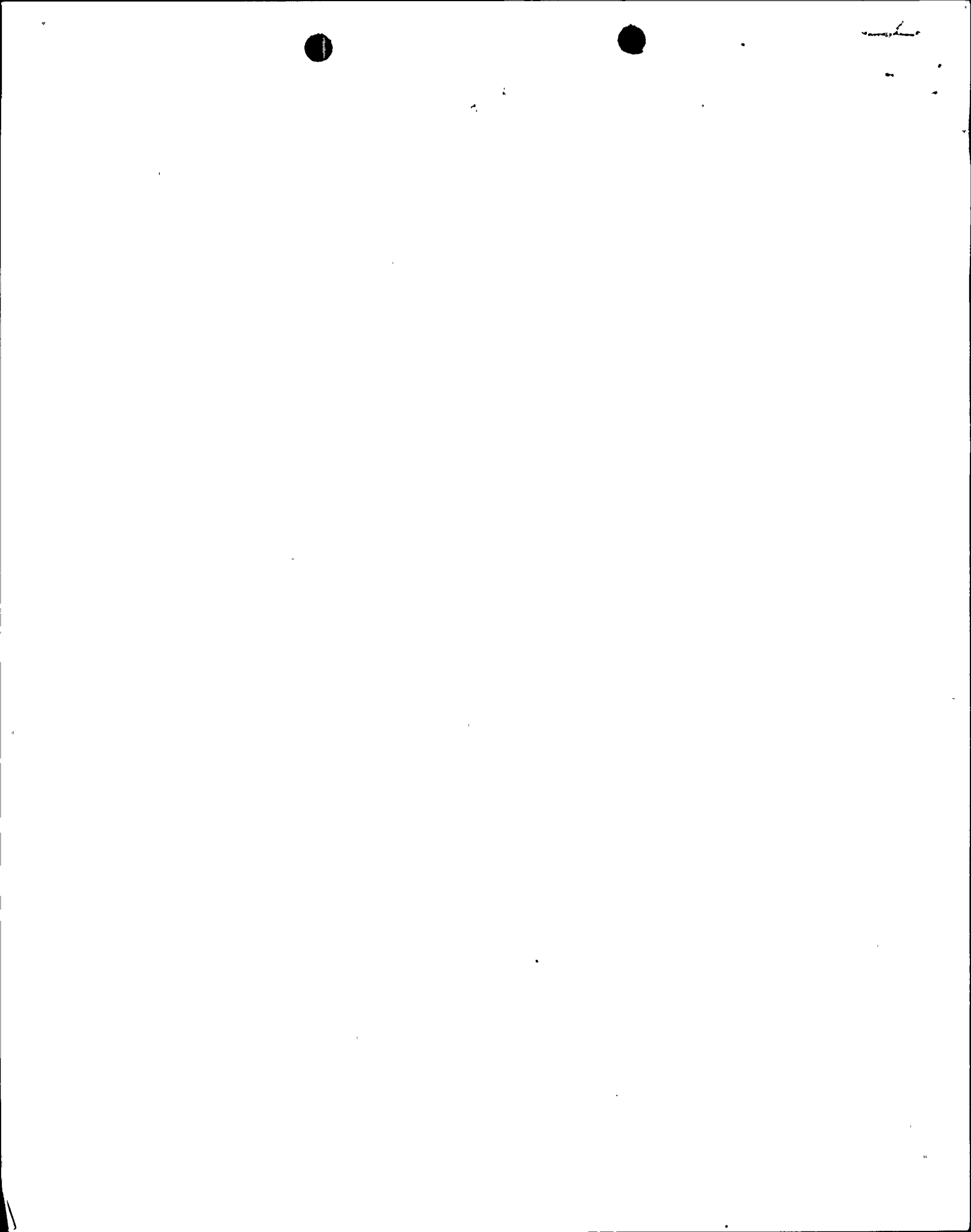
I am opposed to the licensing of the Diablo Canyon nuclear project on the grounds we cannot afford such a nonsensical luxury as inadequate consideration

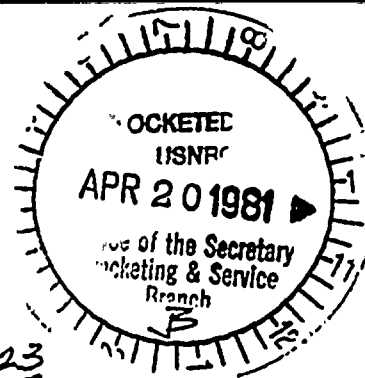

Dear Mr. Hendrie:

This letter is written to express my opposition to the licensing and operation of the Diablo canyon Nuclear Power Plant, near San Luis Obispo, California.

My opposition to the nuclear power generation program is based on the fact that so far the problem of satisfactory and safe, long-term disposal of the radioactive waste has not been solved. The idea that we who are living in 1981 can produce substances which will be lethal for 25,000 to 250,000 years is unacceptable to me; I think we owe it to the future not to leave that kind of legacy.

As a resident of Pismo Beach, I am living within an air distance of less than ten miles from the Diablo Canyon plant. Assuming that an accident resulting from human error causes the release of radioactive vapor, and the wind is blowing in the right direction, I stand an excellent chance of being forced to evacuate my house permanently because it will have been contaminated (perhaps for 25,000 years) by this vapor. Frankly, the prospect does not have any appeal.

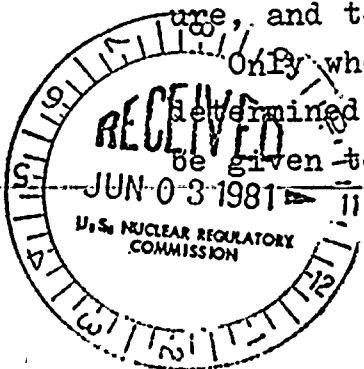
I urge that you and the Commission demand that the Pacific Gas and Electric Company present unequivocating statements as to precisely how the company proposes to get the radioactive waste moved from Diablo Canyon to the safe disposal point, and how they propose to assure that human error (which is the most likely cause of disaster within the thirty-year life expectancy of the plant) will not cause the release of dangerous levels of radioactive vapor. You and your fellow commissioners should insist upon total honesty, total disclosure, and total concern for the safety of all persons in the area.

Only when these questions have been answered completely, and determined to have been answered accurately, should any consideration be given to the possibility of issuing an operating permit.
