SUBJECT:

FEMA SUPPORT FOR NRC LICENSING OF NUCLEAR PLANTS

By separate memorandum for individual nuclear power plants, I have asked that FEMA provide the NRC with findings and determinations as to whether the State and local emergency plans that support a particular nuclear plant are adequate and capable of implementation. These previous memoranda have addressed the Farley, McGuire, Salem and San Onofre facilities.

To assist you in scheduling your support for the NRC licensing procedures we have developed priorities (Enclosure 1) for the facilities that are scheduled for licensing consideration of the NRC in the coming months. The dates indicated for our receipt of FEMA's findings and determinations are based on the current licensing schedules and should allow time for NRC to publish its findings in accordance with the regulations (10 CFR 50.47) on the overall state of emergency preparedness. If changes in priority occur, I will provide you with an updated listing.

If there is a need for additional FEMA assistance, a request will be made by a separate memorandum, specific to a particular nuclear plant. This assistance could include providing testimony and/or witnesses before the Commission, the NRC Advisory Committee on Reactor Safeguards, NRC hearing boards and administrative law judges, any court actions, and during any related discovery proceedings.




