SUBJECT: Diablo Canyon Nuclear Power Facility

In my letter of May 11, 1981, relating to Diablo Canyon, we found that State and local plans and preparedness, at the present time, are not adequate. This finding was provided on the basis of full power operations of the facility and in accordance with Revision 1 of NUREG-0654/FEMA-REP-1. It was not intended to supercede the NRC/FEMA Steering Committee policy on low power operations for Diablo Canyon given the existence of plans previously concurred in by the NRC. Accordingly, the revision of NUREG-0654/FEMA-REP-1 does not apply in the context of the low power operation of Diablo Canyon.


