Gentlemen:

At the October 7, 1982 DCP-IDVP meeting Mr. Engelken expressed, individually to Mr. Maneatis and to me, his concern that the IDVP would employ two former BPC employees in their verification of the DCP Corrective Action Program. Subsequently, I have been involved in conversations on this matter with Mr. Denton, Mr. Denison, Messrs. Reedy, Gibbon and Herbert, Mr. Maneatis and with Messrs. Engelken, Crews, and Bishop. I understand that Mr. Maneatis and Mr. Engelken have also had further discussion, as undoubtedly, have others of which I am not aware.

Based upon all of these discussions and in the interest of completion of the IDVP in a competent and independent manner, I have made the decision to retain both of these individuals on the IDVP effort. This letter is to inform the addressees of this action on my part as IDVP Program Manager, and to present my reasons for having done so. These are:

1. Neither of these individuals are in violation of the IDVP Program. Procedure (DCNPP-IDVP-PP-005) on Conflict-of-Interest, as approved by NRC's letter of September 8, 1982.
2. Neither of these individuals will be verifying work in which the individual participated personally and substantially as BCP employees.
3. These individuals have outstanding qualifications in the applicable technical disciplines and are acting with respect to a particular matter which requires such qualifications.
4. One of these individuals terminated BPC employment more than one year ago and the other more than two years ago.



In addition to the reasons associated with the IDVP, I believe that retention of such individuals is in the best interest of future independent verification programs. The first qualification must be technical competence and professional integrity. If we are to eliminate those knowledgeable and experienced in nuclear power without an established set of criteria related to real or apparent conflict-of-interest, we can have no reliance upon the verifications performed. I would suggest that the criteria applicable to former NRC employees, as stated in Title 10 of the Code of Federal Regulations, Part 0, be applied. In fact, the tabulated items 2, 3, and 4 do this.

I would appreciate any comments on my position and will consider them in performing my function as IDVP Program Manager. However, I intend to proceed with the IDVP efforts as planned and with the participation of these two individuals.
