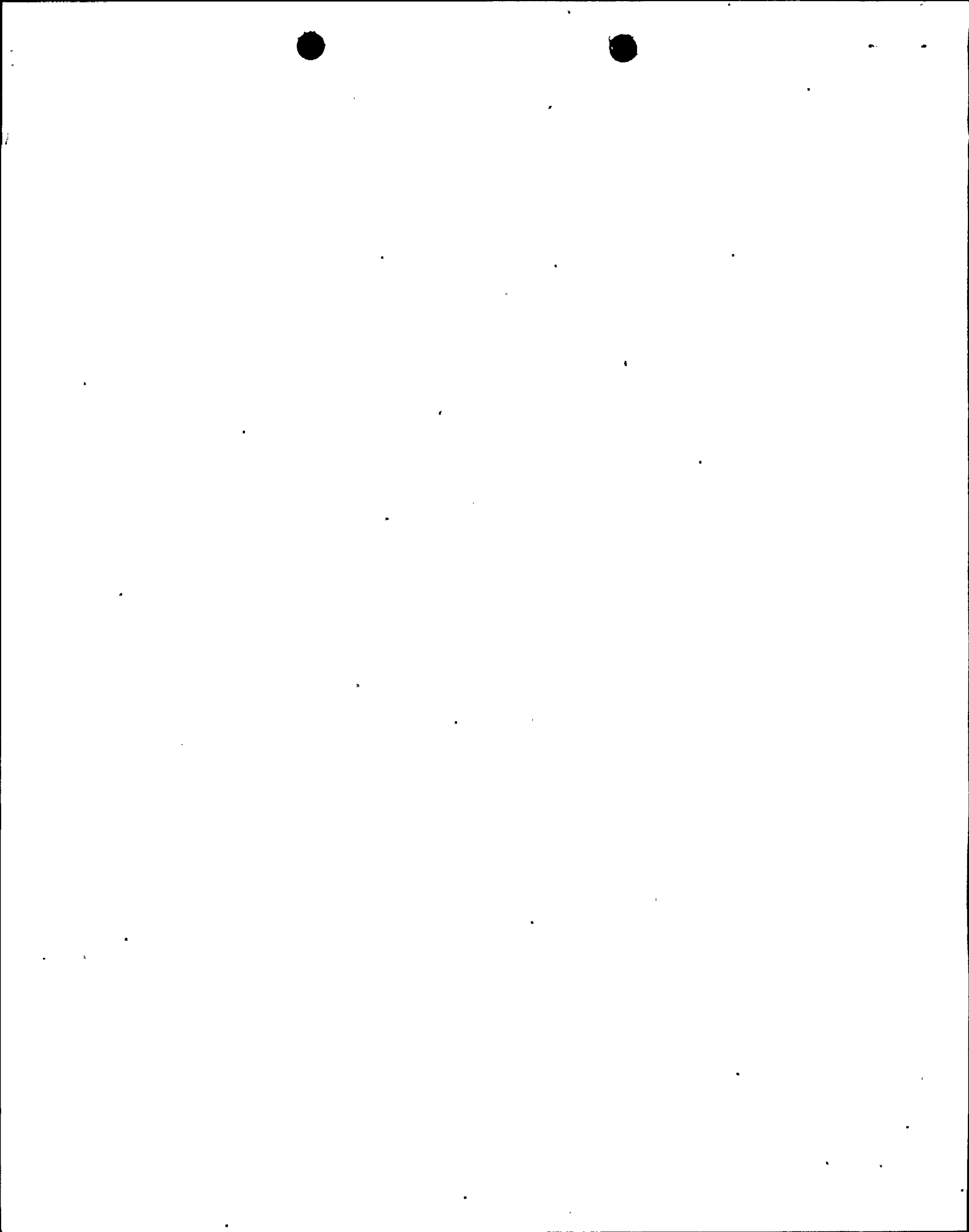


Dear Mr. Knighton:

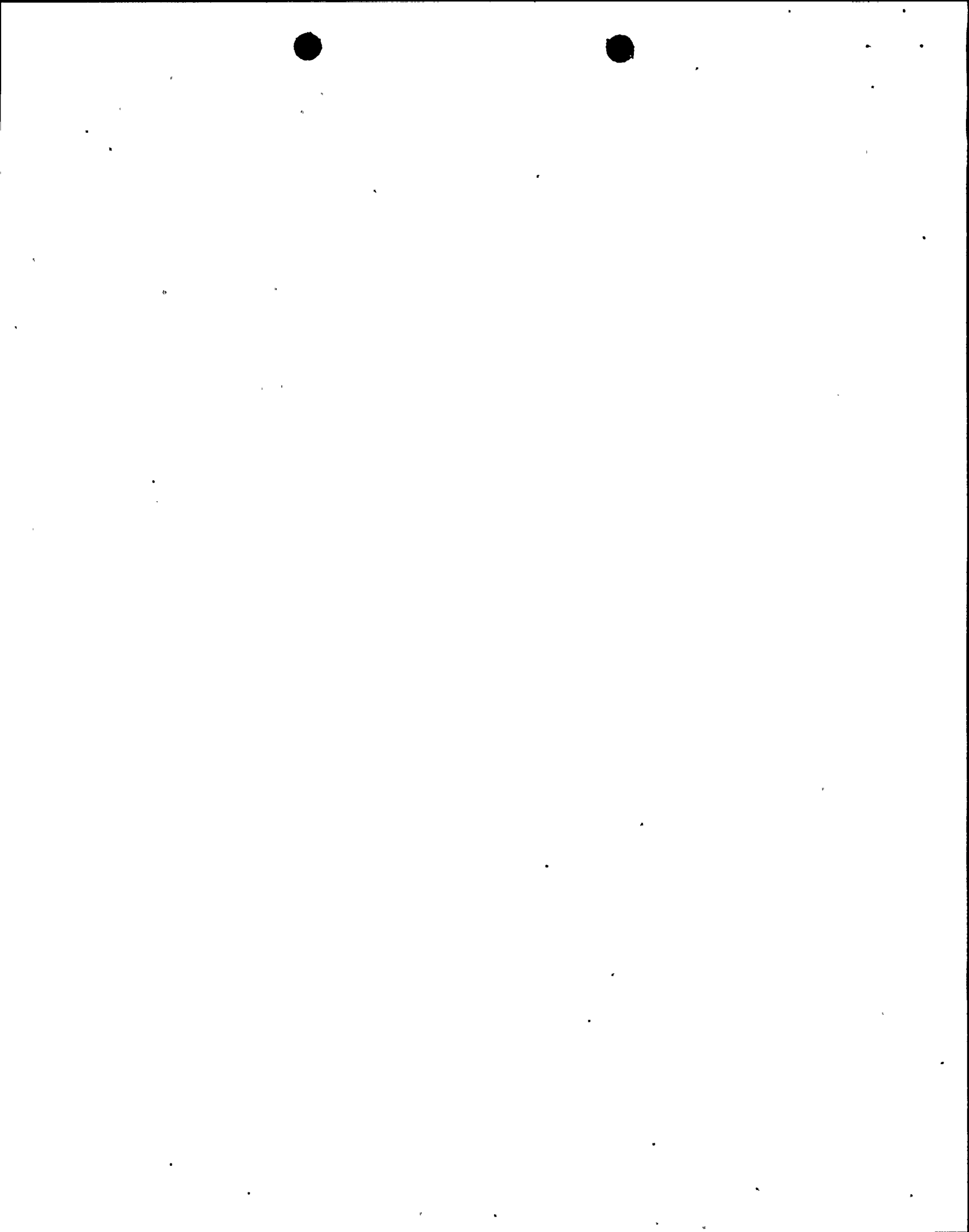
