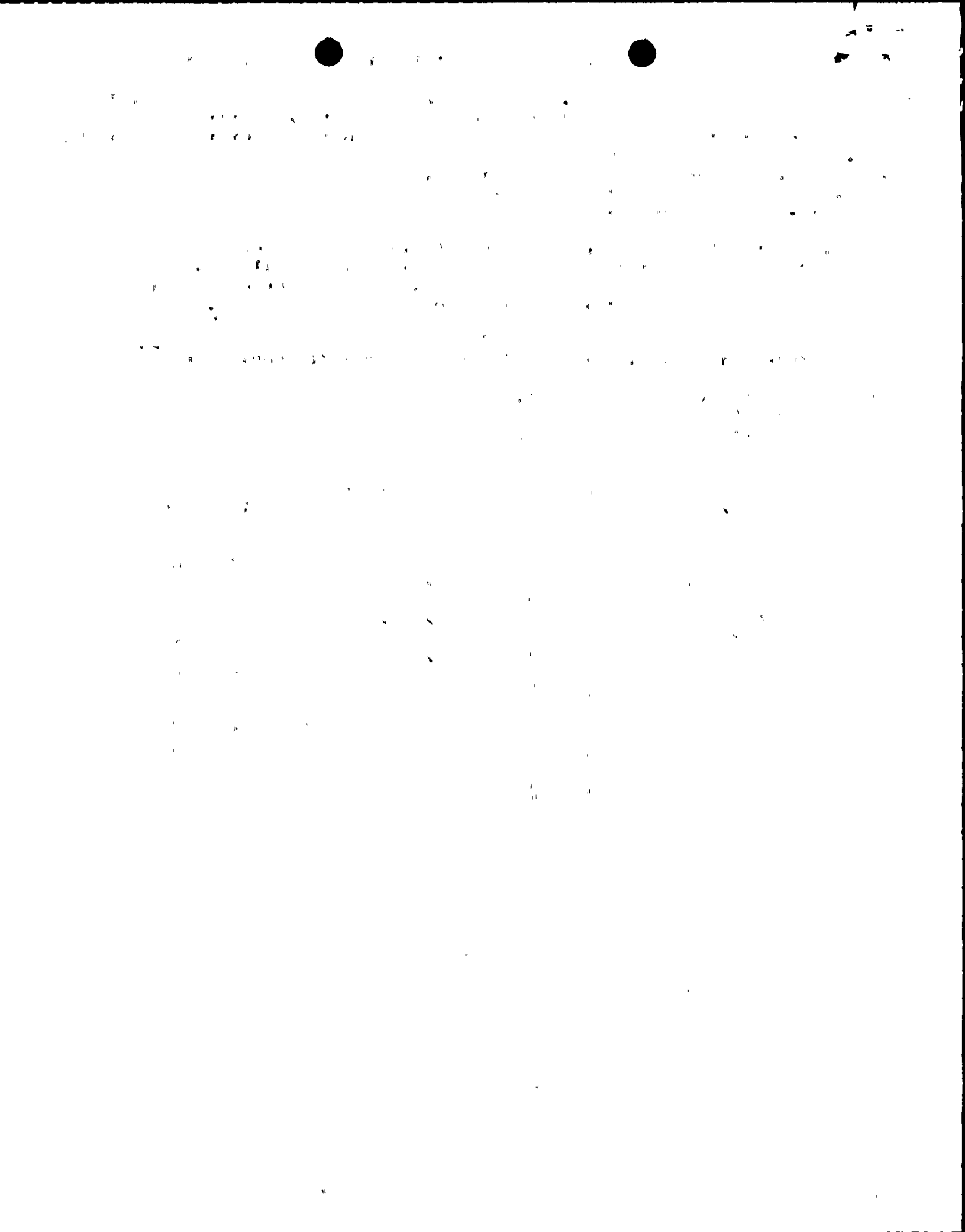


Dear Mr. Knighton:

On April 30, 1984 (Letter No. DCL-84-165), PGandE supplied an update to the tentative schedules for NUREG-0737, Supplement 1 items. Among those updated schedules were Unit 2 schedules for the Technical Support Center (TSC) and the Emergency Operations Facility (EOF).

The TSC and EOF for Unit 2 are now functional. It should be noted that the TSC is one facility which serves both Units 1 and 2. The same is true for the EOF. The Unit 2 Safety Parameter Display System (SPDS) has been installed and is undergoing testing and adjustment. The SPDS is scheduled to be operable by March 8, 1985. PGandE will inform you when the SPDS is fully operable.
