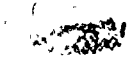

In response to your request dated March 31, 1989, enclosed is the resubmittal of Attachments 2 and 3 of the Diablo Canyon Power Plant Units 1 and 2 Semiannual Radioactive Effluent Release Report for the second half of 1988. Attachments 2 and 3 to the report comprise the current Offsite Dose Calculation Manual (ODCM).

NRC's request for additional information (RAI) of March 31, 1989, asked that this ODCM be resubmitted within two weeks of receipt of the RAI. Because one of the ODCM pages had to be redone to enhance legibility, this response is being supplied one day past the NRC requested due date.

Attachment 3 is Revision 8 of Procedure CAP A-8, "Off-Site Dose Calculation." This revision is the most current and differs slightly from Revision 7 which was included as Attachment 3 of the original submittal.
