Dear Commissioners and Staff:

In accordance with Section V, "Implementing Procedures" of 10 CFR 50, Appendix E, enclosed is an update of the emergency plan implementing procedures (Volume 3B of the plant manual) for the Diablo Canyon Power Plant Units 1 and 2.

Emergency Plan Implementing Procedure EP RB-15, Revision 5, "Post Accident Sampling System," has been rewritten, and related sampling procedures EP RB-15:A through RB-15:O have been rescinded. The emergency plan implementation information that was in EP RB-15:A through RB-15:O has been placed in EP RB-15. The detailed sampling procedure information that was in EP RB-15:A through RB-15:O has been placed in a new set of chemical analysis procedures in Volume 8 of the plant manual.

The Emergency Assessment & Response System (EARS), used for calculating off-site dose projections, has been upgraded with revised software. Emergency Plan Implementing Procedure EF-6, Revision 10, "Operation of EARS," has been rewritten to reflect the revised software.

As provided under 10 CFR 50.54(q), the changes in this update have been made without commission approval since they do not decrease the effectiveness of the emergency plan; and the plan, as changed, continues to meet the standards of 10 CFR 50.47(b) and 10 CFR 50, Appendix E.


