License Amendment Request 97-09 Errata

Dear Commissioners and Staff:

On June 2, 1997, PG&E submitted License Amendment Request (LAR) 97-09, "Technical Specification Conversion License Amendment Request," (PG&E letter DCL-97-106). PG&E developed this conversion application in conjunction with three other utilities: Union Electric (UE) Company, Wolf Creek Nuclear Operation Corporation (WCNOC), and TU Electric.

After the submittal of LAR 97-09, PG&E conducted an extensive Improved Technical Specification (ITS) Bases review in which source documents were identified and consistency checks were performed. During that review and based on some review comments by the Diablo Canyon Power Plant (DCPP) NRR Project Manager, the necessity for several editorial corrections were identified. The enclosure to this letter contains the corrected pages, sorted by TS chapter. The corrections are hand mark-ups so the LAR 97-09 pages requiring replacement can be easily identified. In addition, since June 2, 1997, PG&E has received License Amendments (LA) 119/117 (Unit 1/Unit 2) and 118/116 (Unit 1/Unit 2) on its DCPD 24-Month Fuel Cycle Program. Revised TS pages incorporating the changes approved in those LAs are also enclosed.

There are five categories used to identify the changes and marked accordingly on the enclosed TS pages:

- 210071
- (A) Changes due to inconsistencies between LAR 97-09, Enclosures 5A and 5B (ITS & Bases mark-up), and the proposed ITS and Bases (LAR 97-09, Attachments 19 and 20).
 - (B) Corrections due to source document review and/or development of new LARs that affect the ITS submittal (LAR 97-10, dated July 30, 1997, and LAR 97-06, dated December 23, 1997).

- (C) Changes due to issuance of LAs 119/117 and 118/116.
- (D) Corrections due to errors in the mark-ups (e.g., misuses of the red-line and strikeout features).
- (E) Corrections due to typographical errors.

There are two changes that are included in Section 3.3 Errata based on pending NRC approval of LAR 96-10 (the third 24-Month Fuel Cycle Program LAR). These two changes are included since the applicable surveillance requirements (SR), SR 3.3.2.8 and SR 3.3.1.14, have a 24-month frequency and already affect approved reactor trip system and engineered safety features actuation system functions from LA 119/117 and 118/116. These functions are seismic trip (Table 4.3-1, Functional Unit 23) and auxiliary feedwater, undervoltage reactor coolant pump (Table 4.3-2, Functional Unit 6.d.).


The proposed changes have a minor effect on the consistency between the four submittals made by PG&E, UE, WCNOG, and TU Electric. UE, WCNOG, and TU Electric will address any necessary corrections in their future supplemental submittals. Furthermore, the proposed changes do not affect the conclusions of the no significant hazards evaluation of LAR 97-09.




