Dear Mr. Workman:

On February 16, 2017, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your St Lucie Nuclear Plant, Units 1 and 2. The NRC inspectors discussed the results of this inspection with Mr. C. Workman and other members of your staff. The inspectors documented the results of this inspection in the enclosed inspection report (IR).

No NRC-identified or self-revealing findings were identified during this inspection.

However, inspectors documented a licensee-identified violation, which was determined to be of very low safety significance in this report. The NRC is treating this violation as a non-cited violation (NCV) consistent with Section 2.3.2.a of the Enforcement Policy.

If you contest this violation or significance of this NCV, you should provide a response within 30 days of the date of this IR with the basis of your denial, to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington DC 20555-0001; with copies to the Regional Administrator, Region II, and the Director, Office of Enforcement, United States Nuclear Regulatory Commission, Washington, DC 20555-0001; and the NRC Resident Inspector at the St. Lucie Nuclear Plant.
