I am submitting this application requesting to change the status of the nuclear license at my practice, Raleigh Heart Clinic, Inc. to inactive status. The last nuclear study was performed at my clinic on 01/11/2017.

No use of license material with a bending authorization to restart.

Licensed etiology in 3 isotopes and they will remain shielded in the hot lab.

Thair Ali Barghouthi, MD will remain the radiation safety office. He has been the radiation safety officer for the clinic since 2005.

Last use of radioactive material for cardiac scanning was on 01/11/17. Her last waste disposal 01/12/17

I commit that I will maintain the sources (Ba-133, Cs-137 and Ca-137) secured in storage and they will be inventoried annually by myself (Thair Ali Barghouthi, MD).

I request to limit the radiation safety program as a result of placing the licensed material in storage. These changes include the following:

- a. Stop issuing dosimetry until work resumes.
- b. Worker training will resume if work resumes.
- c. Instruments will be calibrated upon resumption of activities.
- d. An annual audit will be performed of the requirements of this licence.
