The Licensing Support Network (LSN) Library was made publicly available on August 19, 2016. At that time, nearly all of the 3.692 million participant discovery documents from the Yucca Mountain high-level waste repository licensing adjudication that were available on the LSN at the time of system shutdown in August 2011 were accessible on the LSN Library. However, anomalies were found to exist for 130 of the nearly 4 million documents in the LSN Library. [SECY-16-0091 \(ML16210A436\)](#) identified the issues with these 130 documents -- sixty associated with NRC Staff documents and seventy with Yucca Mountain proceeding participants other than the Staff -- and outlined the actions the NRC would take to resolve the identified anomalies.

Regarding those anomalies, for the documents made available on the LSN by participants other than the NRC Staff, prior to web-publication of the contents of the LSN Library, the Office of the Secretary (SECY) and the Atomic Safety and Licensing Board Panel (ASLBP), as the Commission-appointed co-coordinators for the LSN Library project, compared the entries in the system contents list generated by the LSN Administrator (LSNA) at the time the LSN was decommissioned with each non-Staff participant's LSN document collection submitted to SECY when the Yucca Mountain licensing adjudication was suspended. Because the LSNA's shutdown list only contained the LSN number and the associated participant accession number for the documents available on the LSN at the time of system shutdown, the participant accession number was the only piece of information common to both the LSNA's shutdown list and the non-Staff participant's LSN document collections.

This SECY/ASLBP comparison of non-Staff participant accession numbers from the LSNA's shutdown list and the non-Staff participant LSN collections yielded seventy anomalies, which included participant-submitted documents not on the LSNA's shutdown list and documents listed on the LSNA's shutdown list but missing from the participant document collections provided to SECY. Notwithstanding the length of time that has passed since the LSN was shut down, and the resulting limited availability of non-Staff participant representatives with a knowledge of LSN operations, SECY/ASLBP sought to resolve the seventy anomalies based on currently available information, including responses to inquiries made to participant representatives, as described below.

With respect to documents made available on the LSN by the NRC Staff, the indexing process for creating the LSN Library revealed sixty NRC staff documents that, because they had LSN accession numbers on the LSNA's shutdown list, seemingly were publicly available full-text documents on the LSN at the time of system termination. Apparently at some point subsequent to their initial placement in the LSN but prior to system shutdown, these documents were categorized/treated in ADAMS as non-public documents, which is the status they had in ADAMS when indexing for the LSN Library occurred. As LSN Library project co-coordinators, SECY/ASLBP brought this situation to the Staff's attention and sought to resolve these sixty anomalies.

This document provides further information on the current status in the LSN Library of each of the 130 documents with anomalies noted in SECY-16-0091, including the actions taken to address the identified issues.

City of Caliente, Nevada Documents: The LSNA's shutdown list included twenty-three LSN numbers associated with the City of Caliente, Nevada. Consistent with LSN guidelines, these documents apparently were submitted by the City of Caliente in anticipation of seeking to intervene in the Yucca Mountain adjudication. But because the City of Caliente ultimately did not seek to become a party to the adjudication, and so was not on the fourth Construction Authorization Board's (CAB-4) service list when CAB-4 directed each of the then-existing parties to provide their LSN documents to SECY prior to LSN shutdown, the City of Caliente did not forward SECY the documents and the accompanying headers it previously had made available for inclusion on the LSN. SECY began interacting with representatives from the City of Caliente in August 2016 to request copies of the twenty-three documents. As the only information available was the LSNA's shutdown listing of LSN and participant accession numbers, with this limited data the City of Caliente was not able to locate the twenty-three documents so as to provide them for inclusion in the LSN Library. Nonetheless, to ensure the assigned LSN numbers listed on the LSNA's shutdown list are accounted for in the LSN Library, each of the twenty-three documents were added as header only entries and comment field text was added to the LSN Library explaining their status.

March 2016 Update: At the end of December 2016 after the header only entries described above had been completed, the City of Caliente contacted SECY and indicated that it had found the majority of its documents and was working to find the others. In mid-February, the City of Caliente provided a total of twenty-four documents. Of the twenty-three originally identified as LSN items, it was able to find twenty-two documents, but could not find LSN Accession Number CLE000000006. The City of Caliente also indicated that LSN Accession Number CLE000000021 was a duplicate of LSN Accession Number CLE000000004, LSN Accession Number CLE000000003 was a duplicate of LSN Accession Number CLE000000001, and LSN Accession Number CLE000000016 was a duplicate of LSN Accession Number CLE000000005. Additionally, the City of Caliente provided two additional documents that it indicated should have been part of its LSN collection. These documents were added with new LSN Accession Numbers CLE200000001 and CLE200000002. With the exception of CLE000000006, the comment field for which was not altered from what was originally loaded, the following text was incorporated into the comment field in the City of Caliente headers for each of the added documents:

But because the City of Las Vegas ultimately did not become a party to the adjudication, and so was not on the CAB-4 service list when CAB-4 directed each of the then-existing parties to provide their LSN documents to SECY prior to LSN shutdown, the City of Las Vegas did not forward SECY the document and the accompanying header it previously had made available for inclusion on the LSN. SECY began interacting with representatives from the City of Las Vegas in August 2016 and requested a copy of the one document. As the only information available to the NRC was the LSNA's shutdown listing of the document's LSN and participant accession numbers, based on this limited information a representative of the City of Las Vegas provided a document titled "Yucca Mountain: The Facts." In the e-mail transmitting this document, the representative stated "I'm not sure this is the actual document but this is a brochure we had during that timeframe." The document provided by the City of Las Vegas was added to LSN Library with the following text in the comment field:

Among the documents DOE gave to SECY in response to CAB-4's direction at the time of system shutdown, seven were very large documents, running between 1.45 and 3.67 gigabytes.

Of the seven large documents, the NRC was able to reduce the size of two of the portable document format (PDF) documents using the Adobe Acrobat “Reduced Size PDF” save-as option. Twenty-one documents from parties/interested governmental entities were listed on the LSNA's shutdown list but were not provided to SECY by those participants in response to CAB-4's direction at the time of system shutdown. To resolve this discrepancy, Churchill County was asked to confirm that the correct participant number was that provided by Churchill County rather than the number on the LSNA's shutdown list, which Churchill County did.

Relative to the additional documents provided by Lander County and Mineral County listed above that were originally thought to be new documents because their participant accession numbers were not found in the LSNA's shutdown list, as noted earlier on pages 12 and 14 above, it was subsequently determined that these were, in fact, duplicates of documents already submitted to SECY at the time of system shutdown. This duplication was revealed when Lander County and Mineral County were contacted to provide documents that were listed on the LSNA's shutdown list but were not found in their submitted LSN collections. Upon review of the submitted documents, it was determined that the documents listed above as new documents submitted to SECY at the time of system shutdown were, in fact, among the submitted documents that appeared to be missing from these participants' original SECY submissions. The reason for the misidentification was incorrect participant accession numbers in the header information accompanying the counties' original SECY submissions. To clarify the discrepancy, Lander County and Mineral County were again contacted by SECY and confirmed that the header information in the original submissions was incorrect. As noted earlier on pages 12 and 14 above, the header information for each of the documents was modified to reflect the correct participant accession numbers.
