Subject: Request for Additional Information

Discussion: In the letter dated 2/2/17, UVM requested that Carl Nelson, MD be added to the license as an authorized user for 35.600 uses. UVM provided the appropriate, completed 313, however the ABR certificate that was provided did not show the date. I requested that B. Oyadomari resend the ABR with the date showing. In addition, in a letter dated 2/28/17, UVM requested that the four - 1.1 millicurie custom Cobalt-57 sealed sources (Dwg. No. PR03012010, Rev. B) be removed from the license. During the 2017 inspection, UVM stated that the sources were sent to Pharmalogic for eventual disposal. They provided documentation from Eckert & Ziegler stating that 1 – 4 millicurie Cobalt 57 source was received from Pharmalogic. I asked that B. Oyadomari provide documentation that clearly states that 4 1 mCi Co-57 sources were received by Pharmalogic from UVM for disposal.
