Dear Dr. Howell:

Enclosed is Amendment No. 14 renewing your NRC Material License No. 13-05737-01 in accordance with your request. Please note that your license format was changed based on our new licensing process system.

In addition, we deleted License Condition 18 regarding the transportation requirement in your previous amendment because the requirement is already specified in the regulations. We also updated License Condition 15 regarding the sealed source leak test requirement and Condition 18 regarding the physical source inventory requirement.

You requested to remove Room 124, an area of use located in Dennis Hall, from your license. Based on the provided information, we have concluded that all licensable radioactive material has been removed from this room and residual radioactive material attributable to licensed activities does not exceed NRC requirements. Therefore, we have authorized the release of Room 124 in Dennis Hall located at 801 National Road West, Richmond, Indiana, for unrestricted use.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture. You can access the policy statement and supporting material that may benefit your organization on NRC's safety culture


