Subject: Memorandum of Understanding Regarding the Systematic Alien
Verification for Entitlements (SAVE) Program

Consistent with U.S. Nuclear Regulatory Commission (USNRC) Order EA-02-261
(Reference 1), Exelon Generation Company, LLC (Exelon) and Constellation Energy Nuclear
Group (CENG, now owned by Exelon) entered into a Memorandum of Understanding (MOU)
regarding the Systematic Alien Verification for Entitlements (SAVE) Program. In the
Reference 2 letter, the USNRC rescinded Order EA-02-261.

Exelon is providing notification of our intent to terminate the MOU regarding the SAVE
program and any associated commitments to this program. Exelon will continue to maintain
full compliance with all applicable security regulations.


