Gentlemen:

Thank you for your letter of May 2, 1975, in which you set forth an updated schedule for submission of environmental information related to the Diablo Canyon Station. Since receipt of your letter we have received Supplement 4 to the Environmental Report as well as other reports relating to the redress of the transmission line corridors.

We remain concerned that much essential information will not be forthcoming until July or later. I am referring specifically to reports covering the following:

- a. 1974 monitoring programs and ocean current studies;
- b. entrainment and impingement studies;
- c. chlorine toxicity; and
- d. the results of a physical model of the plant and alternative discharge systems.

The results of these studies will be needed to allow us to make an updated assessment of potential changes in the ecosystem of Diablo Cove and the adjacent ocean areas for the Environmental Statement Addendum. Each day of delay in the submission of the above information makes it difficult to establish dates for the issuance of the addendum with resultant delay of the environmental hearing.
