Dear John,

Trijicon would like to install Tritium sources into the "Trijicon Insight ANPSQ-18A installed on an M203," further referred to as the (ANPSQ-18A). Under Trijicon's License Registration Certificate No. NR-0418-D-101-E the ANPSQ-18A would be under the device type: "Luminous Gun sight," model D- Sealed Light Sources Installed in Iron Sight inserts mounted on weapons. For the ANPSQ-18A to be used under model D, the sight is required to have certain size constraints, material type, material or wall thickness around the source, and maximum tritium activity. The ANPSQ-18A meets all of these requirements.

Trijicon would like to amend our Registration Certificate to add the ANPSQ-18A as a sub-heading under "section D- Sealed Light Sources Installed in Iron Sight inserts mounted on weapons." NRC License No. 21-19874-02E and Registration Certificate No. NR-0418-D-101-E.


