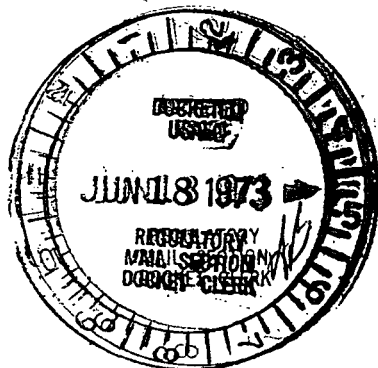
Dear Mr. Skovholt:
