13 FOR PEACE, and to redesignate HARRY M. WILLIS as lead counsel of record.

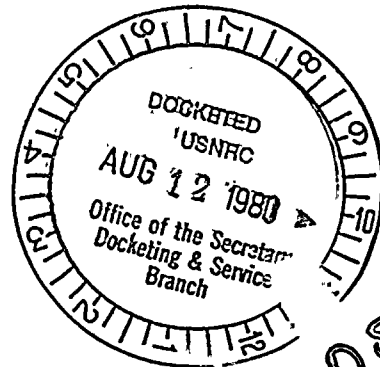

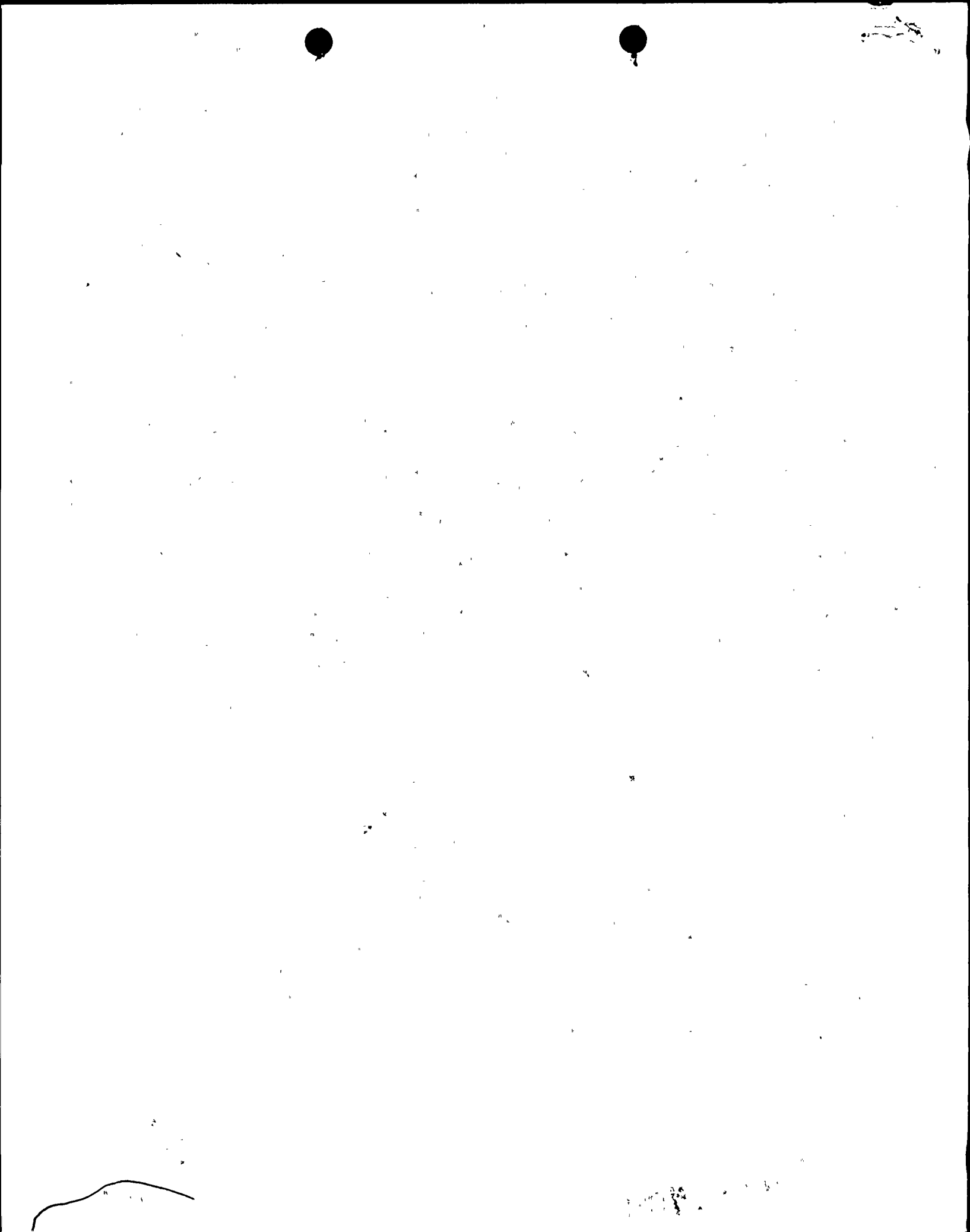
