The X-ray fluorescence analyzer was not separated out for the two different maximum sources. I suggested that the maximum possession would be 5 units for each grouping of sources. Mr. Juliani said it would be acceptable. I informed him that Troxler 4640 and 4640-B does not have a Am-241:Be source and thus it would not be included on the license. He said he knew that and was a mistake on his letter. I asked if the cell phone for Mr. Lowder was a personal or business cell phone. He said that he believed it was a business cell phone.
