We have not done any brachytherapy under 10 CFR 35.400 in 2016

Our physicist, Evelyn Sebastian, reported on January 2, 2017 that all ¹²⁵I and ¹⁰³Pd sources were removed and sent to the manufacturer to hold for decay and disposal. After the sources were removed from the storage cupboard, shelves and the area were wiped to confirm there was no residual radiation contamination present. The wipes for these areas were counted in a well chamber and the results were 0 cpm
