**Inspection, Test, Analysis, and Acceptance Criteria Inspection of Vogtle 3 & 4 and Summer 2 & 3**

During the week of March 27, 2017, staff participated in an AP1000 Equipment Qualification Inspection, Test, Analysis, and Acceptance Criteria (ITAAC) Inspection for the Vogtle 3 & 4 and Summer 2 & 3 plants. The purpose of the inspection was to verify: 1) that the licensee is using the appropriate design basis parameters for qualification and that the design basis was appropriately translated into the systems, structures, and components (SSCs) qualification test; 2) that the required qualification of SSCs has been completed in accordance with regulatory requirements, design specifications, and approved procedures; and 3) that licensee records establish an adequate basis for acceptance of ITAAC with qualification criteria attributes. Staff from the Electrical Engineering Center of Expertise reviewed the harsh and mild qualification summary and test reports for the reactor trip switchgear, electrical penetrations, and air-operated plug valves. There were no findings for this inspection.
