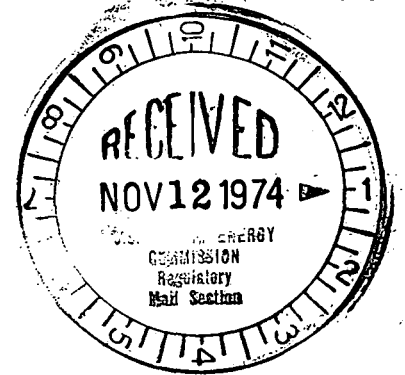

Attached is the subject report which describes modifications to the handling systems suitable for precluding postulated drops of a 100 ton spent fuel shipping cask.

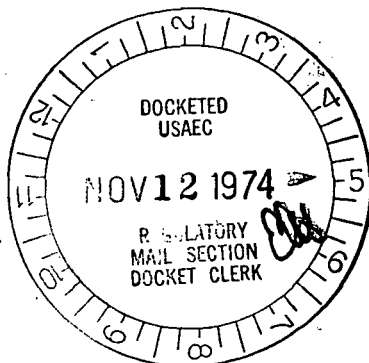
Your approval is requested to handle spent fuel shipping casks weighing up to nominally 100 tons with the handling system described in the attached special reports.

Design and procurement of materials for the crane modifications described in the attached special reports is in progress. Fabrication of new crane parts is currently scheduled to begin in early 1975; therefore, your approval of the proposed design as any acceptable spent fuel cask handling system is requested by February 1, 1975. Approval by this date would allow completion of the modifications and shipment of spent fuel on a schedule that would alleviate any significant adverse impact to onsite spent fuel storage capacity.


