In accordance with 10 CFR 50.54, "Conditions of licenses," paragraph (p)(2), Exelon Generation Company, LLC (EGC) is submitting supplemental information related to Revision 12 of the Quad Cities Nuclear Power Station (QCNPS) Site Security Plan as requested by NRC, Mr. John Frost, at a meeting with EGC on February 22, 2017. No changes are being made to Revision 12 of the QCNPS Site Security Plan.

EGC has concluded that the attached supplemental information (Attachment 1) does not decrease the safeguards effectiveness of the QCNPS Site Security Plan, Safeguards Contingency Plan, Training and Qualification Plan, and Independent Spent Fuel Storage Installation Plan.
