SUBJECT: SUMMARY OF PUBLIC MEETING

On March 21, 2017, at 6:00 p.m., an annual assessment meeting and exit meeting for the supplemental inspection performed at Pilgrim Nuclear Power Station (Pilgrim), in accordance with Inspection Procedure 95003, was conducted at Plymouth Memorial Hall in Plymouth, Massachusetts, between the U.S. Nuclear Regulatory Commission (NRC) and Entergy Nuclear Operations, Inc. (Entergy). The NRC presented and discussed its assessment of the safety performance of Pilgrim for calendar year 2016, and NRC staff discussed their conclusions from the 95003 inspection performed as a result of the station entering into the Repetitive Degraded Cornerstone Column (Column 4) of the NRC's Reactor Oversight Process (ROP) Action Matrix.

The NRC presentation for the annual assessment meeting discussed the results of NRC's assessment of safety performance at Pilgrim for the period of January 1 through December 31, 2016, as documented in our letter dated March 1, 2017 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML17059B917). During the 95003 inspection exit portion of the meeting, NRC staff presented their assessment of the Pilgrim recovery plan for Column 4 performance. The NRC staff also posed questions to Entergy management regarding the actions they are taking to address these conclusions. As part of this meeting, Entergy presented its perspective regarding the plant's performance. Copies of the slides presented by both the NRC and Entergy are included as enclosures to this meeting summary.

Members of the public, local and State officials, and staffers representing local area congressional offices attended the meeting. At the end of the meeting between the NRC and Entergy, public attendees were offered the opportunity to ask questions of NRC officials or make statements. Several local and State representatives provided statements regarding the information presented at the meeting. Additionally, several prepared statements from U.S. congressional offices were read by staffers at the meeting; copies of these prepared statements

are included as enclosures to this summary. Questions raised by members of the public were addressed by the NRC.
