## SUBJECT: NRC INSPECTION REPORT NO. 03033533/2016002, STAMFORD HOSPITAL, CONNECTICUT SITE AND NOTICE OF VIOLATION

Dear Ms. Silard:

This refers to the routine, unannounced inspection conducted on October 18, 2016, at your facility in Stamford, Connecticut, with continued office review until March 16, 2017. This inspection examined activities conducted under your license as they relate to public health and safety, the common defense and security, to confirm compliance with the U.S. Nuclear Regulatory Commission's (NRC's) rules and regulations, and with the conditions of your license. A final telephonic exit briefing to discuss the results of the inspection was conducted with you on March 16, 2017.

Based on the results of this inspection and in accordance with the NRC Enforcement Policy, the NRC has determined that five violations of NRC requirements occurred. The current Enforcement Policy is included on NRC's Web site at

<u>http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html</u>. The violations are cited because they were identified by the NRC. The violations appear in Enclosure 1 to this letter. Enclosure 2 provides a determination of severity level and a description of the corrective and preventative actions taken by Stamford Hospital, to address the violations.

The NRC has concluded that information regarding the reason for the violations, the corrective actions taken and planned to correct the violations and prevent recurrence is already adequately addressed in our records. Therefore, you are not required to respond to this letter unless the description of your corrective actions in this letter does not accurately reflect your corrective actions or your position. In that case, or if you choose to provide additional information, you should follow the instructions specified in the enclosed Notice.
