Discussion: (15:00; 4/10/17) I spoke with Mr. Johnson because Mr. King was in the field. I asked Mr. Johnson if the licensee had performed an evaluation of the high dosimetry readings mentioned in the licensee's March 24, 2017, letter. Mr. Johnson stated that he did not know if an evaluation had been performed or a change request sent to the dosimetry processor. I requested that Mr. King get back in with me. (10:20; 4/11/17) Mr. King returned my phone call. He stated that an evaluation had not performed but there was now enough data to perform one. Once performed, a request to the dosimetry processor to amend the record would be made. The same procedure would be used for any future evaluations. I thanked Mr. King for the information.
