Calculation Summary - Perform a confinement evaluation for the NUHOMS® system to be stored at the WCS Interim Storage Facility (ISF) in accordance with NUREG-1536 Revision 1 and NUREG-1567. Exposures due to postulated releases of radionuclides will be calculated for normal, off-normal, and accident conditions and compared to the criteria of 10CFR72.104 and 10CFR72.106.

Please advise as soon as possible if this calculation was updated and re-submitted, either with your March, 2017 submittal or previously during the acceptance review, or if you replaced it with another calculation.
