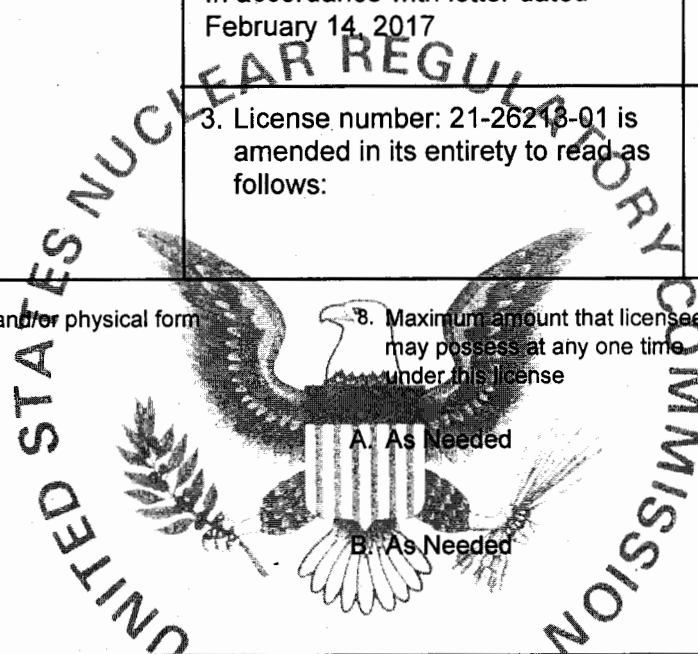


MATERIALS LICENSE

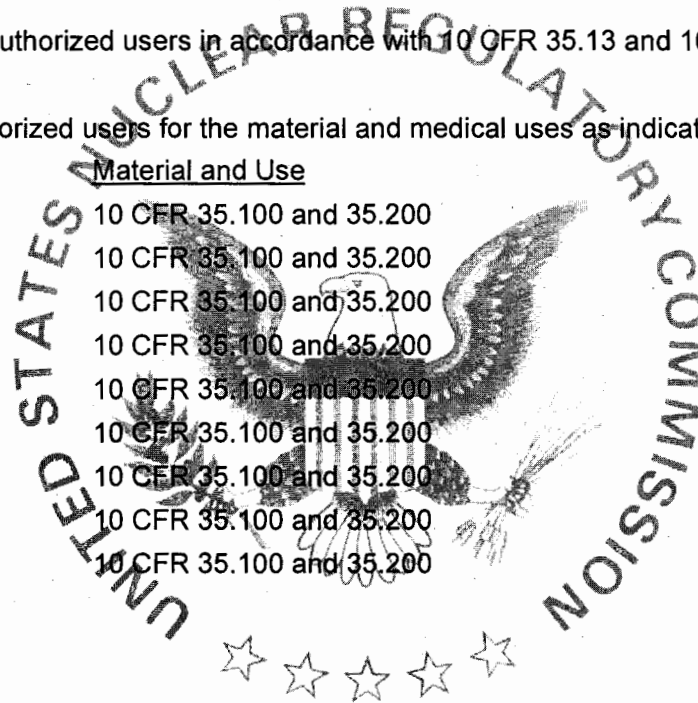

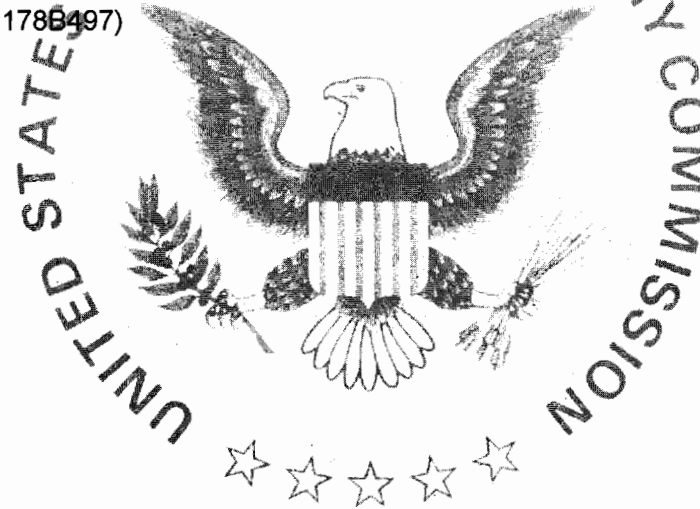
