This refers to your license amendment request dated January 24, 2017. Please find enclosed Amendment No. 38 authorizing the unrestricted release of Building M-745.

Building M-745 located at Aberdeen Proving Ground may be released for unrestricted release. An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(20).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
