Dear Dr. Bondre:

By letter dated June 16, 2015 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML15173A379), as supplemented on July 30, 2015 (ADAMS Accession No. ML15223A204), December 18, 2015 (ADAMS Accession No. ML15364A399), April 7, 2016 (ADAMS Accession No. ML16111A670), June 13, 2016 (ADAMS Accession No. ML16169A044), and July 28, 2016 (ADAMS Accession No. ML16215A015), AREVA Inc. (now TN Americas, LLC) submitted an application to the U.S. Nuclear Regulatory Commission (NRC) to obtain a certificate of compliance (CoC) for the NUHOMS[®] EOS dry spent fuel storage system to provide horizontal storage of high burnup spent pressurized water reactor and boiling water reactor fuel assemblies in dry shielded canisters. The certificate, when codified through rulemaking, will be denoted as CoC No. 1042, Initial Certificate (Amendment No. 0).

As stated in the *Federal Register* (82 FR 14987, 3/24/2017), the effective date of this CoC is June 7, 2017. The NRC's safety evaluation report (SER) for this CoC (including Appendix A, Technical Specifications) is enclosed. This certificate constitutes the approval and conditions for use of THE NUHOMS[®] EOS Horizontal Modular Storage System for Irradiated Nuclear Fuel Storage System for storage of spent nuclear fuel under the general licensing provisions of 10 CFR 72.210.
