In its letter dated April 24, 2017, the Advisory Committee on Reactor Safeguards (ACRS) reported on its safety review of the staff's safety evaluation report for the NuScale Power, LLC, Licensing Topical Report TR-1015-18653-P, "Design of the Highly Integrated Protection System [HIPS] Platform," Revision 1 (Agencywide Documents Access and Management System Accession No. ML17069A135). The ACRS concluded that the HIPS platform is acceptable for use in plant safety-related instrumentation and control systems provided that its implementation satisfies the staff's application-specific action items. The Committee recommended that the staff's safety evaluation report of NuScale topical report TR-1015-18653-P, Revision 1 should be issued.

The staff appreciates the ACRS' review and recommendation. The staff plans to issue the safety evaluation report by mid-June 2017.

We look forward to working with the ACRS in the future.
