Dear Ms. Sayer:

On March 31, 2017, the U.S. Nuclear Regulatory Commission (NRC) cited Premier Technology, Inc. for violations involving the NRC's public health and safety and security requirements. The March 31, 2017, Notice of Violation (Notice) required you to respond to one security-related violation. You responded by letter dated April 26, 2017.

After reviewing the information you provided in your response to the Notice, we have concluded that your completed and proposed actions appear to adequately address the regulatory noncompliance described in the Notice. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.
