SYNOPSIS

This investigation was initiated by the U.S. Nuclear Regulatory Commission (NRC), Office of Investigation (OI), Region II, on May 15, 2015, to determine whether a former Operations Lead Instructor employed by Duke Energy at the Oconee Nuclear Plant (Oconee) was discriminated against for raising safety concerns.

Based upon the evidence developed during this investigation, OI:RII did not substantiate that the former Operations Lead Instructor employed by Duke Energy at Oconee was discriminated against for raising safety concerns.
