On April 20, 2017, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your San Onofre Nuclear Generating Station, Units 2 and 3. The NRC inspector discussed the results of this inspection with Mr. L. Bosch, Plant Manager, and other members of your staff. The inspector documented the results of this inspection in the enclosed inspection report.

The NRC inspector did not identify any findings or violations of more than minor significance.
