Dear Mr. Stratton:

This is to inform you that in an attempt to be more responsive to the needs of the public, the Commission has established locations where members of the public can inspect documents relating to applications for nuclear power plants that are currently under review or recently have been licensed for operation by the Commission. These locations are in close proximity to the nuclear facilities and, in most instances, are in public libraries to provide easy access to the public.

The Commission has established the following local document rooms relating to Commonwealth Edison Company's operating Units 2 and 3 of the Dresden Nuclear Power Station located in Grundy County, Illinois, and Units 1 and 2 of the Quad-Cities Station located in Rock Island County, Illinois:

1. Morris Public Library (for Dresden 2 & 3)

2. Moline Public Library (for Quad-Cities 1 & 2)
504 - 17th Street
Moline, Illinois 61265

The above document rooms have been provided copies of the respective operating licenses issued by the Commission for the above nuclear facilities, and all amendments, changes and orders related thereto. They have not been provided copies of Commonwealth's initial applications and amendments thereto or Commission actions that preceded issuance of
