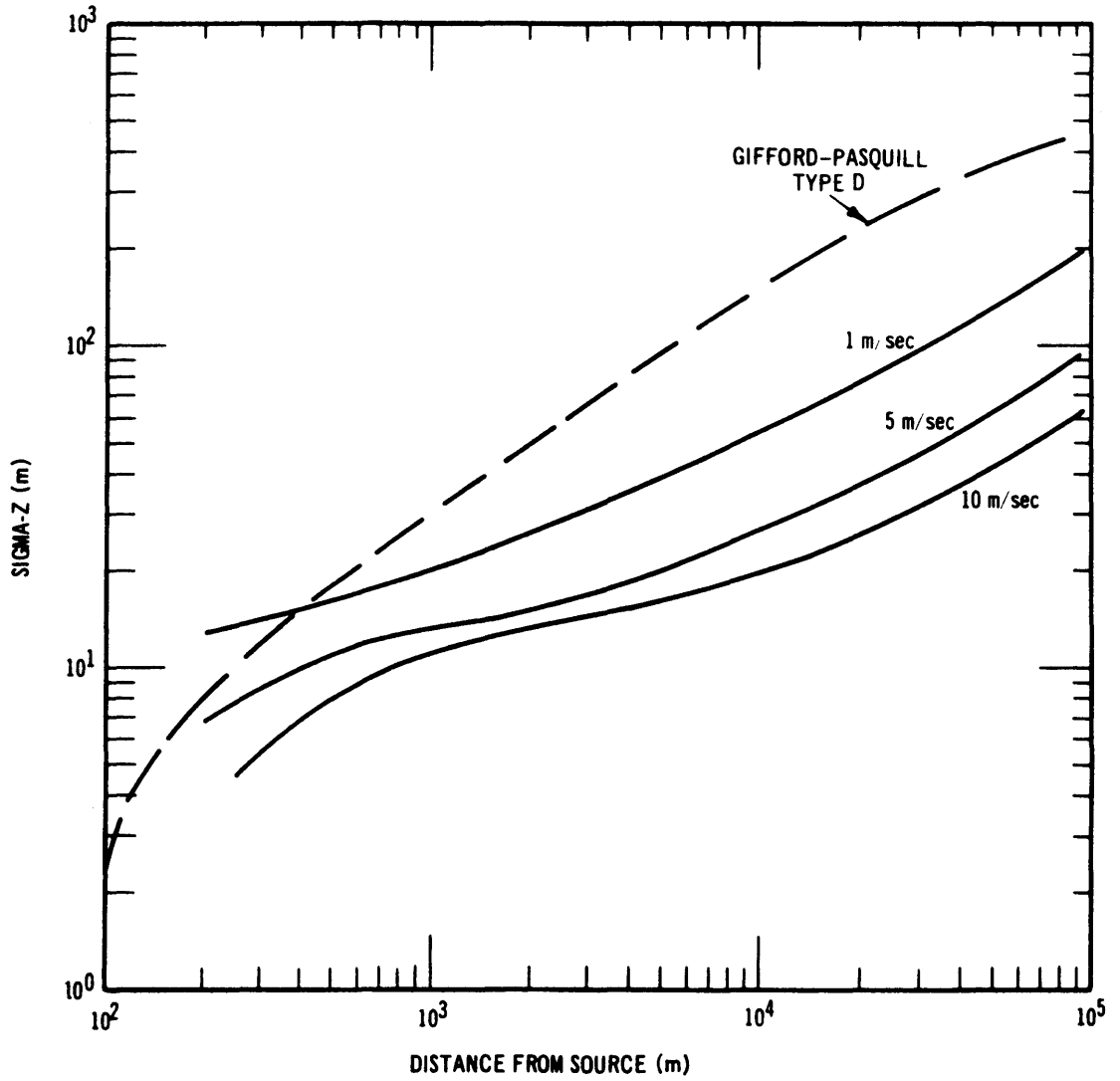

VERY STABLE**

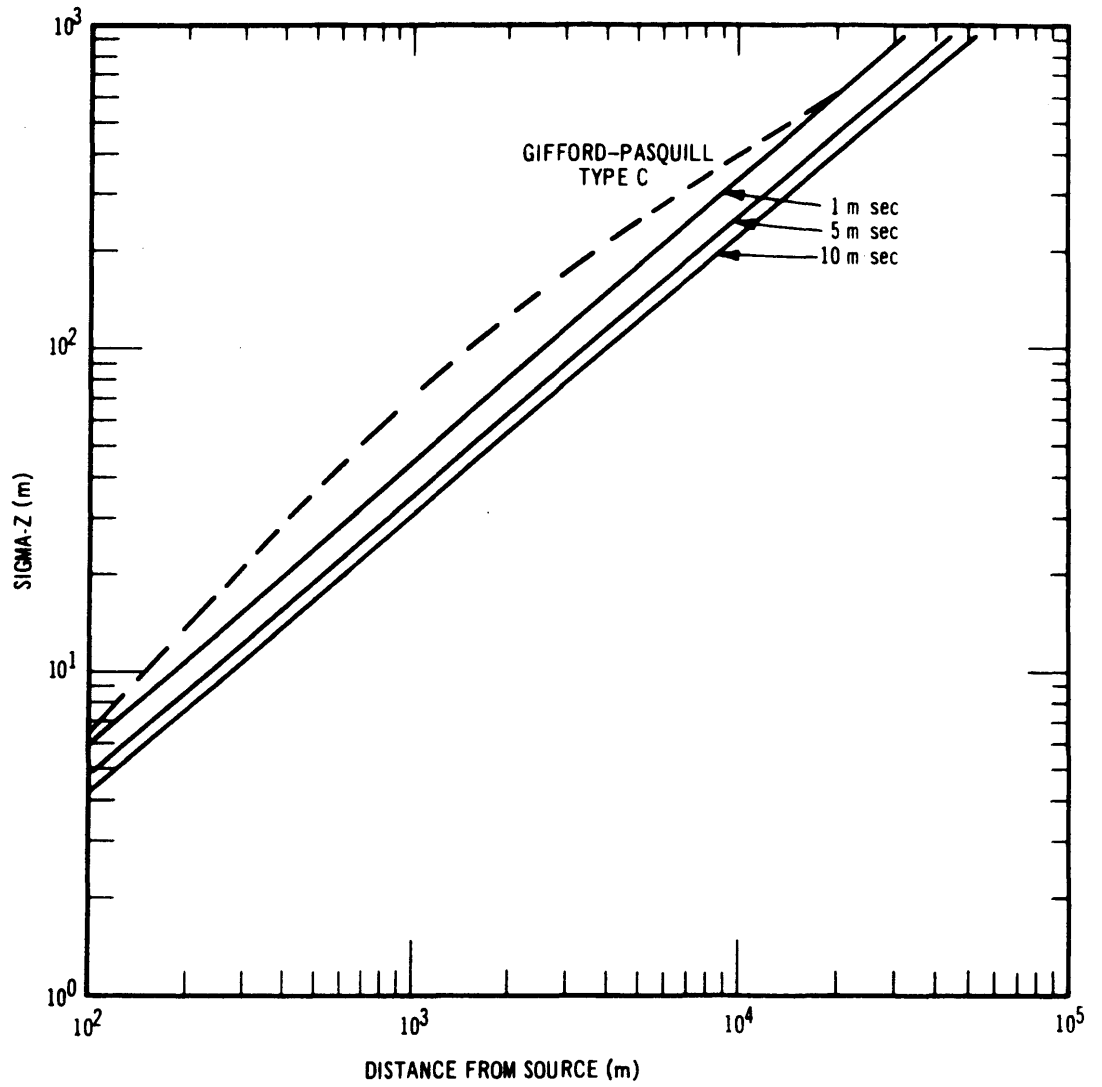

MODERATELY STABLE**

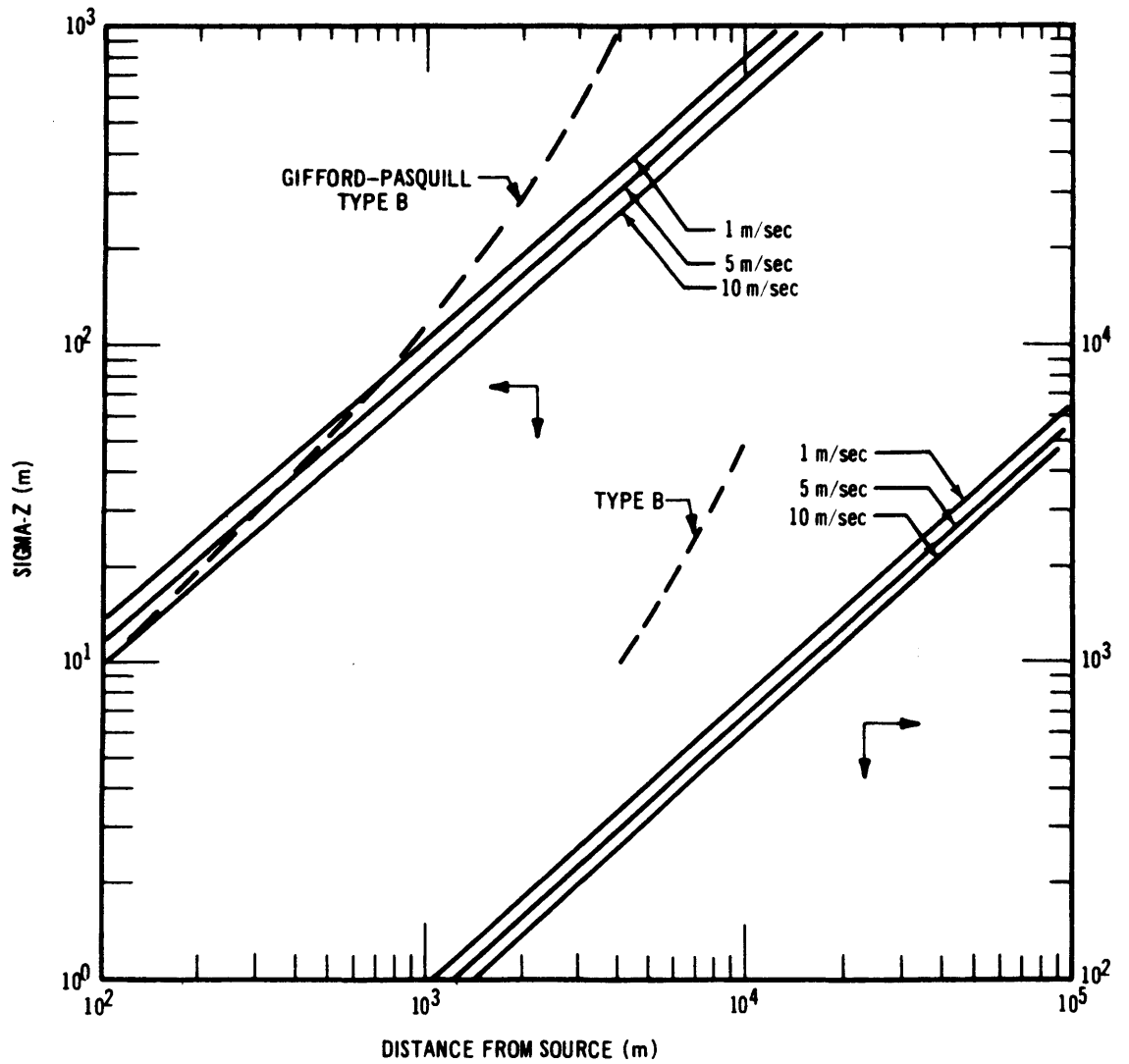

NEUTRAL**

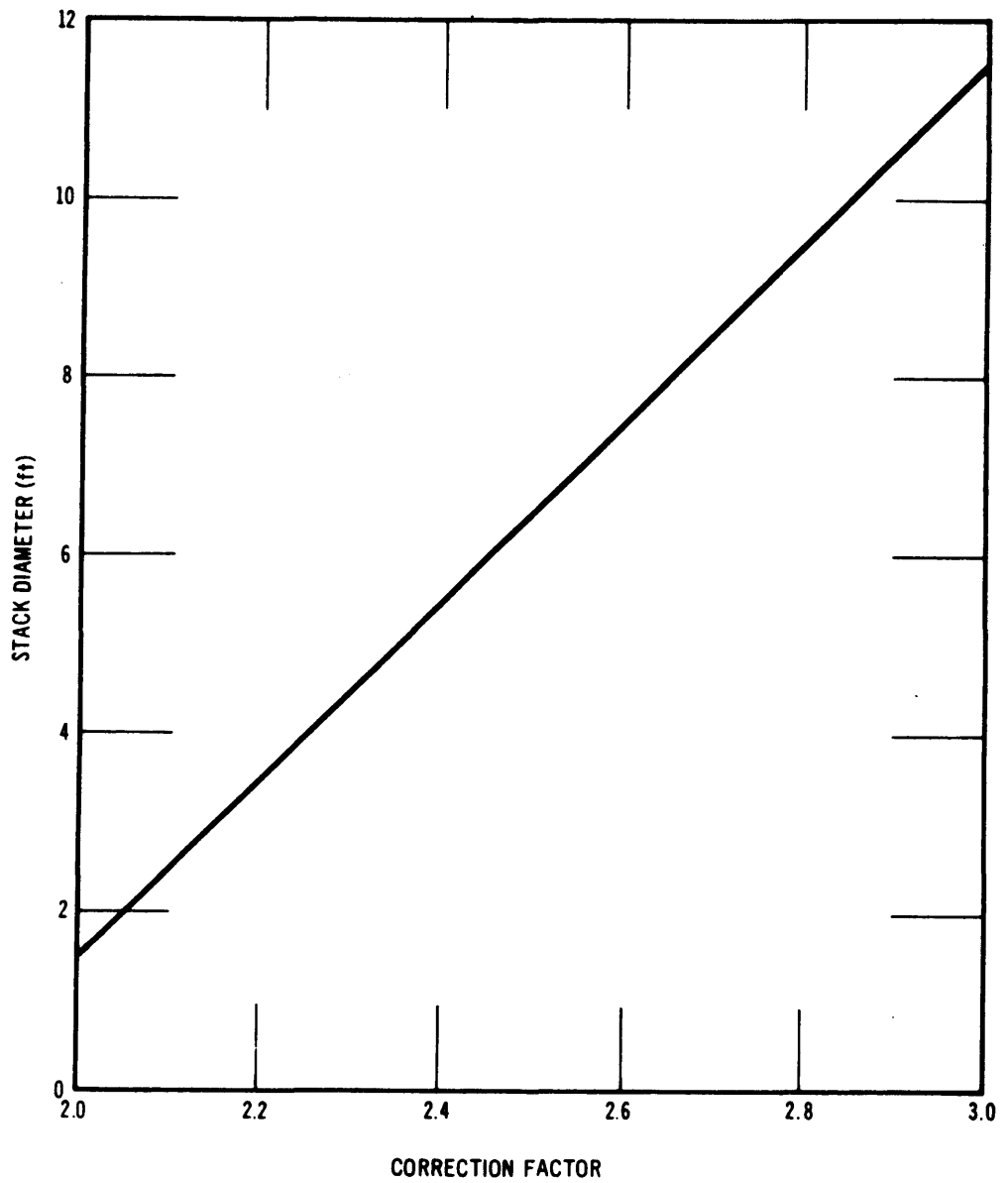

UNSTABLE**

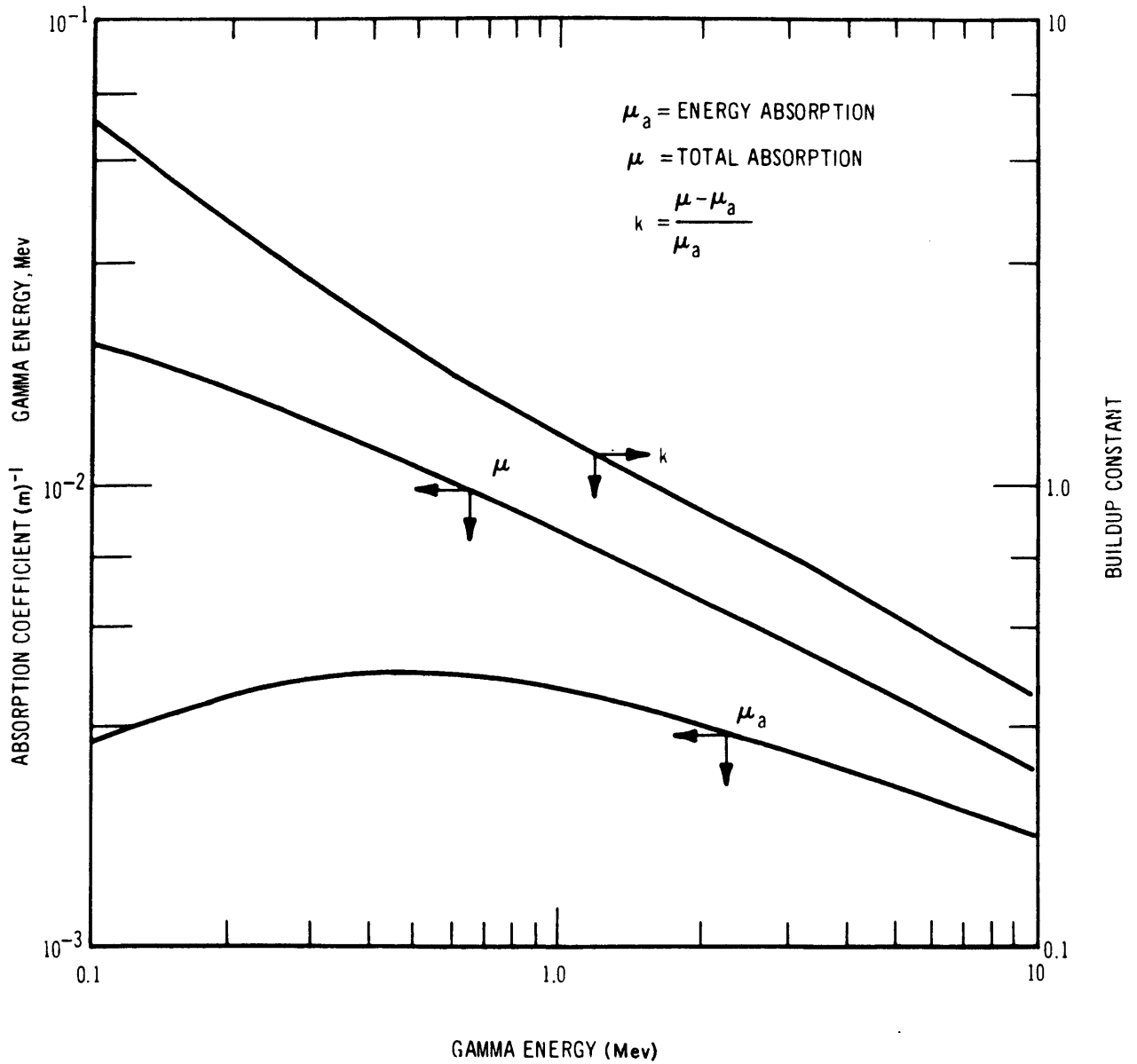

CORRECTION FACTOR**

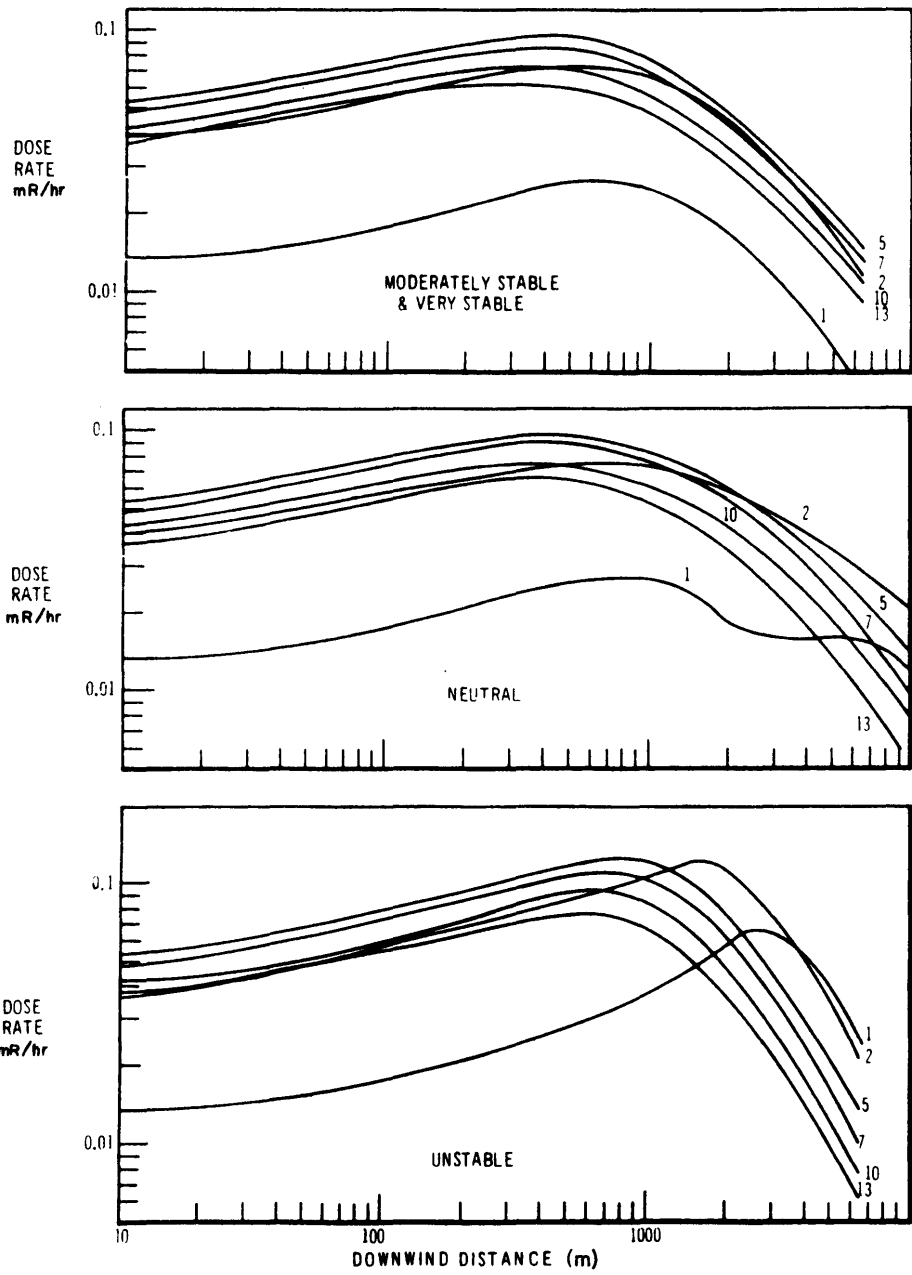

 CONSTANTS FOR AIR, STP**

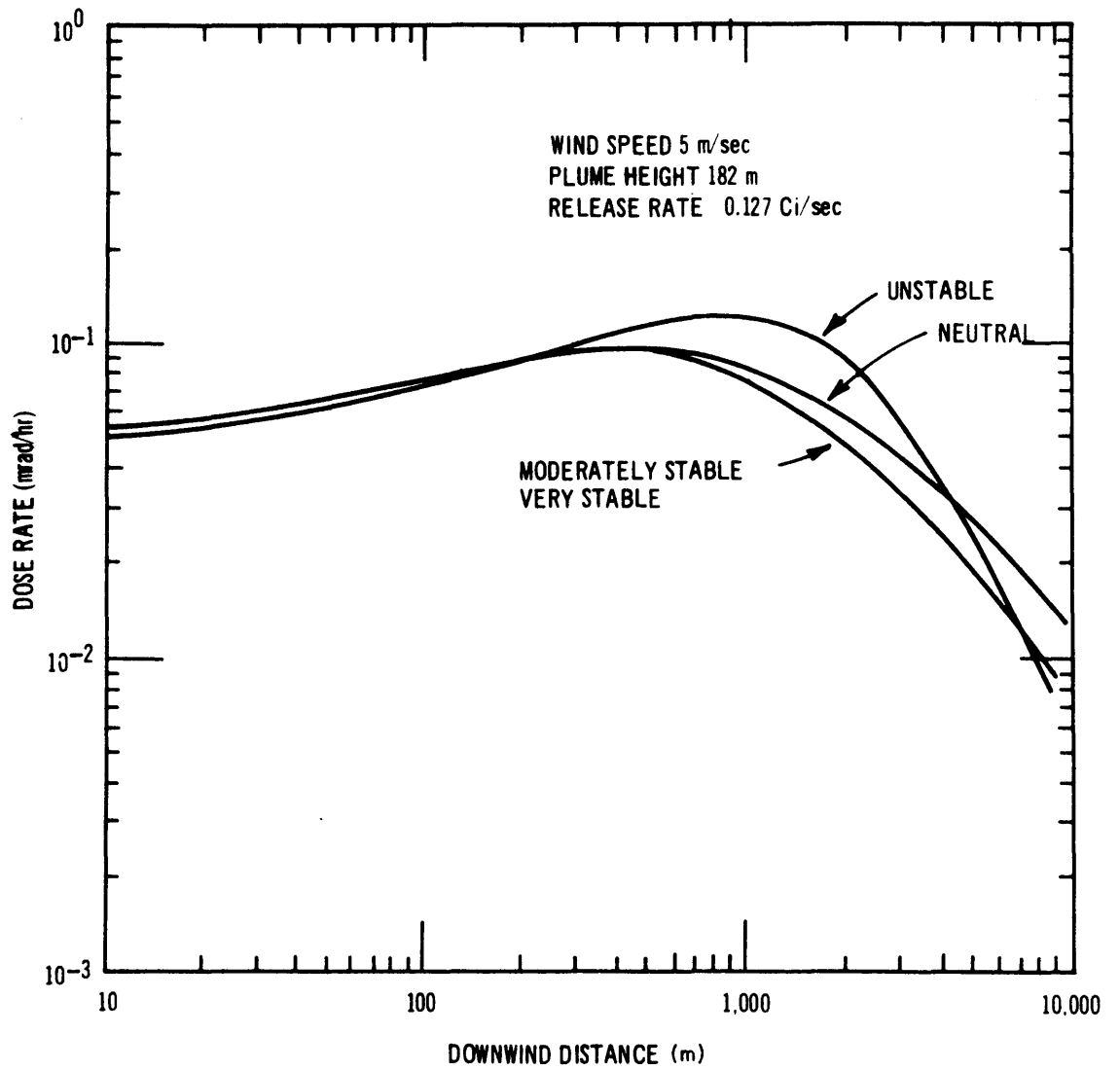

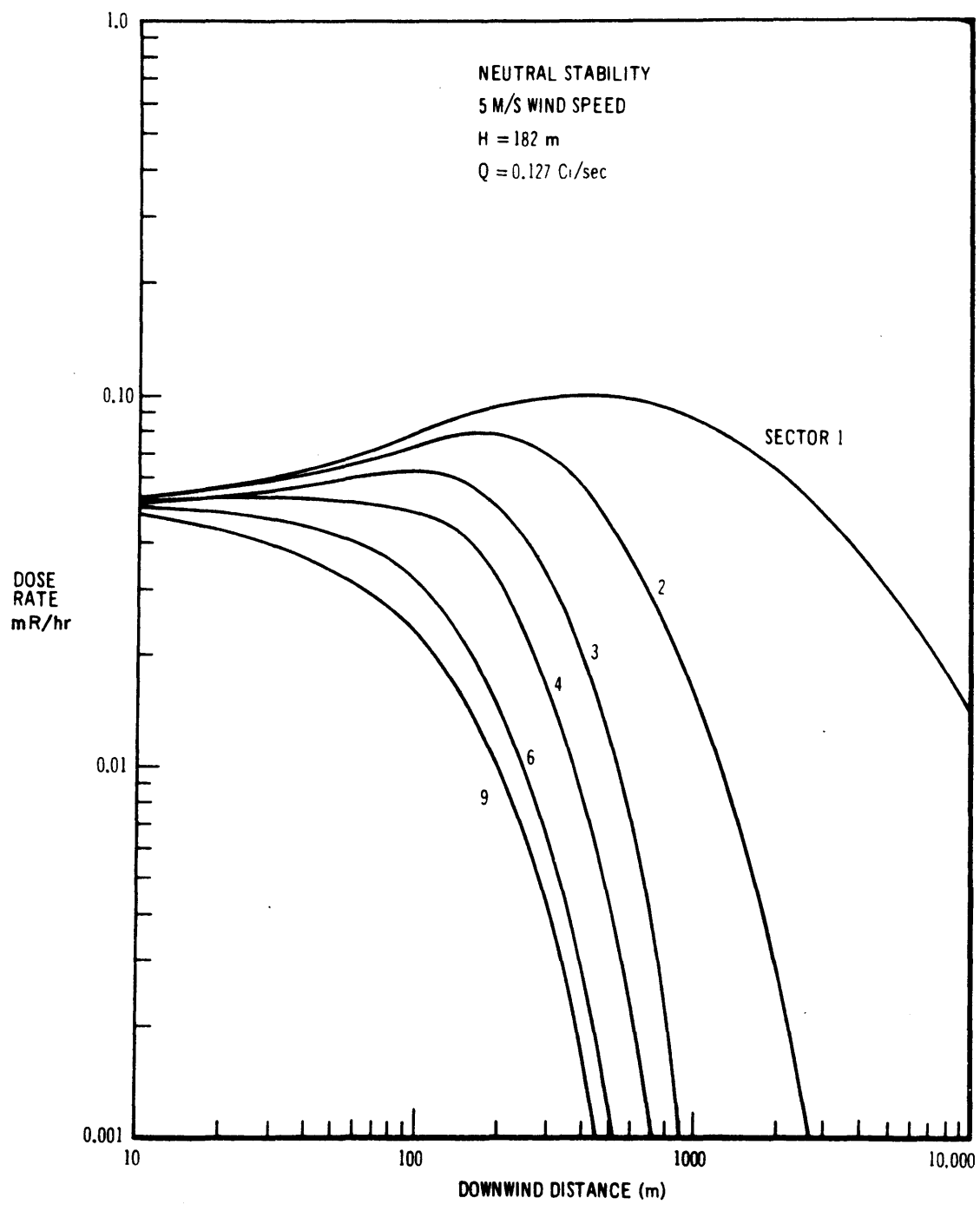

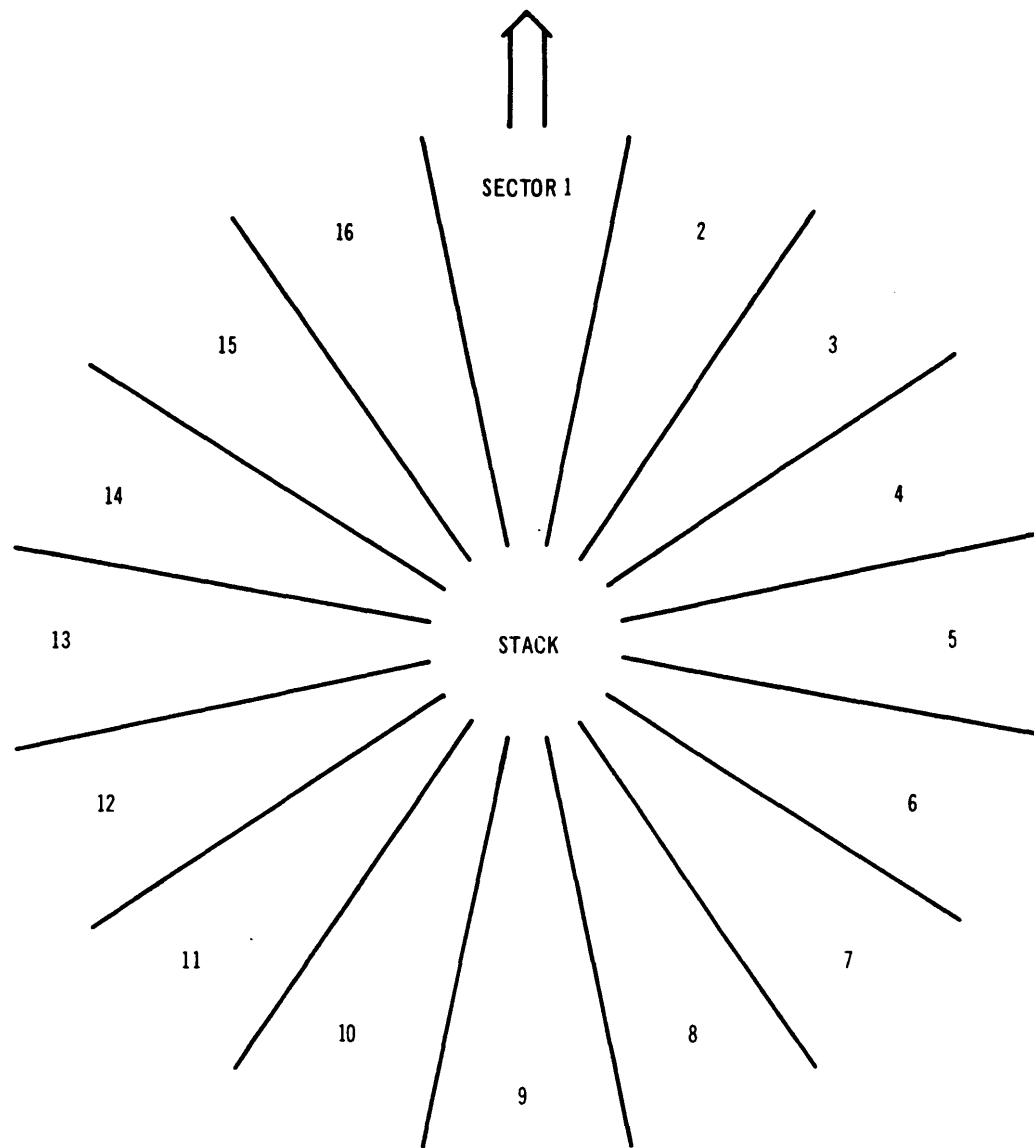

**DOSE RATE IN EACH SECTOR**

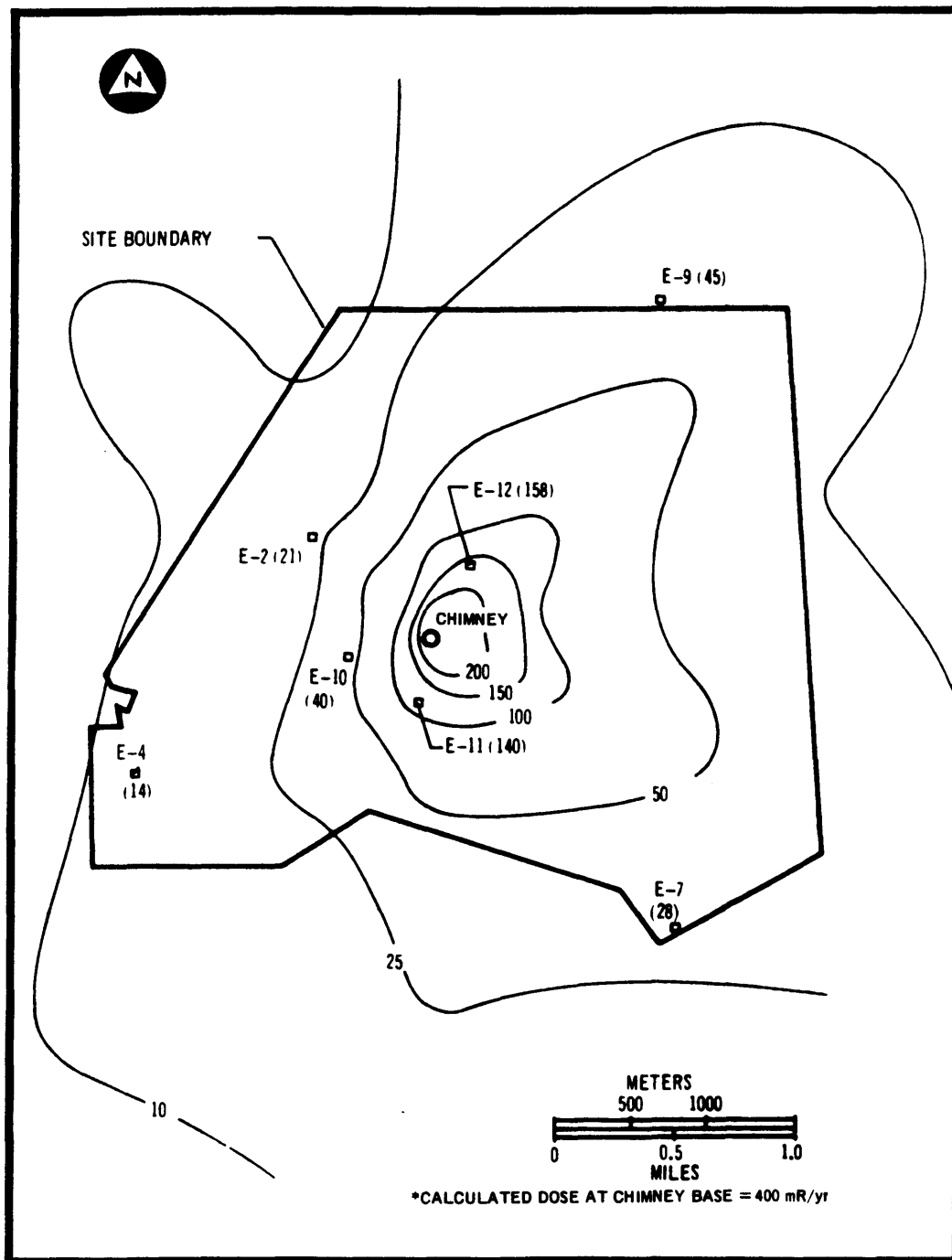
