Dear Mr. Lee:

Our continuing environmental review of Dresden 2 and 3 has revealed the need for certain information not covered in the Environmental Report. Accordingly, please submit the information identified below:

1. Your procedures for clearing and maintaining transmission line rights-of-way. Types, quantities and frequency of application of any herbicides should be included.
2. The width and depth of the Unit 1 discharge canal. The capacity (gpm) of the pumps for Units 2 and 3 intake. The capacity (gpm) of the lift station pumps.
3. The condition of two archaeological sites that may have been damaged during construction of the Dresden site (I.D. Nos. Gr-2, Gr-3). Describe the present condition of these sites, the significance of any damage and your plans to insure that additional damage is not inflicted on any archaeological sites resulting from the presence of the Dresden Station.
4. The horizontal and vertical dimensions, location and all entrances to the abandoned mine beneath the Dresden cooling lake. Also include the geological formations above the mine, the present condition of the mine (flooded, empty, etc.), and any other pertinent information relative to the mine.
5. The total acreage and boundary map of the land owned by CECO at the Dresden site.

Your reply should consist of three signed originals and 197 additional copies as a sequentially numbered amendment to your Environmental Report. Please hold 100 additional copies subject to call by the AEC.
