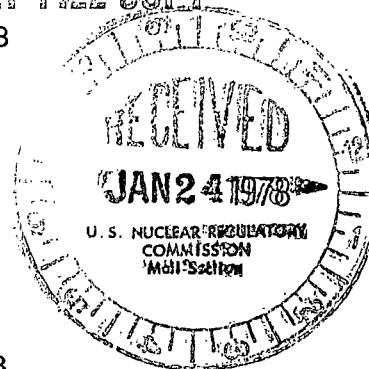

Dear Mr. Davis:

As requested in References (a) and (b), the startup/shutdown cycles on Dresden Units 2 and 3 and Quad-Cities Units 1 and 2 are being monitored. These cycles are being counted in accordance with the criteria set out in General Electric Service Information Letter (SIL) No. 207, i.e., a startup/shutdown cycle is a reactor thermal power increase from nominally zero and subsequent return to zero which produces both pressure and temperature changes.

Tabulated below are the startup/shutdown cycles which Dresden Units 2 and 3 and Quad-Cities Units 1 and 2 have undergone during the third quarter of 1977:
