Enclosed are the amendments, listed below, to your NRC Material Licenses in accordance with your letters dated January 25, 2017.

Please note that we have changed the system used to prepare licenses, which has resulted in several changes to your licenses. These changes include the removal of the license condition referring to transportation of materials in accordance with current NRC policy to include the reference to Title 10 of the Code of Federal Regulations, Part 71, "Packaging and Transportation of Radioactive Material;" in the preamble, on page 1 of the license. On License No. 21-02335-08, we have also amended Condition No. 17 in accordance with current NRC policy. Finally, we have added NRC's Agencywide Documents Access and Management System (ADAMS) document accession numbers to the documents referenced in the amended licenses.

Please review the enclosed documents carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.


