Subject: Notification that DFP re-evaluation not submitted

Discussion: On January 18, 2017, I spoke with Mr. Stinson about whether a re-evaluation of the Decommissioning Funding Plan (DFP) had been submitted to the NRC for review. Mr. Stinson stated that the re-evaluation had not been performed as of that date but he would see to it that the re-evaluation was submitted. I informed Mr. Stinson that the re-evaluation was due in December 2016 and that he should submit the document as quickly as possible. The re-evaluation should consider changes in labor rates, disposal costs, and the current state of the program including expected radioactive wastes and clean-up of contaminated areas. Mr. Stinson stated that he did not realize that the re-evaluation was late and would try to complete the re-evaluation as soon as possible.
