**RE: IMPORT OF NON U.S. ORIGIN RADIOACTIVE SOURCES**

Dear SPEC Client,

Please be advised that SPEC complies with the NRC's Regulatory Guide regarding Source Imports, 10 CFR Part 110 including the 2013 Branch Technical Position on the Import of Non-U.S. Origin Radioactive Sources; 10 CFR Part 110 (NRC-2012-0008). Specifically, SPEC does not accept radioactive material, sealed sources or devices containing sealed sources that are not of U.S. origin and are sent to SPEC solely for the purpose of disposal, decay or waste management.

Shipments imported by SPEC must comply with NRC's Import Regulations in accordance with 10 CFR Part 110. Prior to shipment please provide all source documentation, including but not limited to, air waybill, dangerous goods form, commercial invoice and source certificates/decay graph. If this information is not available or does not comply with NRC's regulation, SPEC can not accept the source for import.


