This refers to the routine safeguards inspection conducted by Mr. R. J. Bailey of this office on July 22-26, 1985 at Salem Township, Pennsylvania of activities authorized by NRC License Nos. NPF-14 and NPF-22 and to the discussions of our findings held by Mr. Bailey with Mr. T. M. Crimmins of your staff at the conclusion of the inspection.
